2. Contract Price:

8. PAYING AUTHORITY: All payments shall be made from the Corporation's Corporate Office, Shillong. The Sr. Manager (Bills), NEEPCO, Lower New Colony, Shillong shall be the paying authority. However, the invoices shall be submitted, in triplicate to this office for certification.

9. Price Adjustment:

This is a fixed cost contract with firm prices. No price adjustment shall be payable against the Contract and no claim in this regard shall be entertained during the entire period of contract.

10. LIQUIDATED DAMAGES FOR DELAY:

If, for reasons attributable to the Consultant, the Consultancy Services is not completed within the time for completion, NEEPCO shall be entitled to liquidated damages (which is a preestimate of the loss/damage NEEPCO would have suffered on account of delay) and the said damages shall be payable by the Consultant on demand without there being any proof from NEEPCO of the actual loss and damages caused by such delay and all sums payable by way of liquidated damages shall be considered a reasonable compensation without reference to the actual loss and damage which shall have been suffered by NEEPCO on account of such delay and not as a penalty.

The liquidated damages shall be payable for delay in completion of Services @ 1/2 % (Half percent) of the Contract Price per week of delay or part of week of delay, subject to a maximum of 10% of the Contract Price

You are requested to submit the following immediately so as to enable signing of the Contract Agreement.

- A Contract Performance Guarantee is to be furnished in the form of Bank Guarantee for (i) an amount equal to 10%(Ten percent) of Contract Price in the prescribed format as set out in Appendix-GCC1 in terms of clause 5.5 of Part-II(Instruction to Bidders and Forms & Data Sheets) of detailed Bid document within 15 (fifteen) days from the date of issue of this order.
