The undersigned, on behalf of the Corporation hereby invites online bids under Single stage Two Envelope system through Domestic Competitive Bidding (DCB) route with a validity of 180 (One Hundred Eighty Days) from authorised dealers/ manufacturers for “**Supply of Valves and Flanges for 3 X 135 MW Dikrong Power House, Ranganadi H.E. Plant, NEEPCO, Arunachal Pradesh**”, as detailed herein under::

1. SCOPE:

The scope of work shall be “Supply of Valves and Flanges for 3 X 135 MW Dikrong Power House, Ranganadi H.E. Plant, NEEPCO, Arunachal Pradesh” as per BOQ and delivery of same to Power House Store, Hoz, Papumpare Dist, Arunachal Pradesh. The terms and conditions governing this tender are detailed in the subsequent sections of the Bid Document. The details of supply of the items required, is given as **Annexure – A**.

2. COMPLETION TIME:

The delivery period of materials shall be 90 (Ninety) Days from the date of issue of detail supply order.

3. QUALIFYING REQUIREMENT:

a) TECHNICAL: The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.

- (i) Trade License of the firm showing his credential as a dealer of Industrial valves & flanges.
- (ii) In case of a company, Certificate of incorporation in case of a company.
- (iii) In case of a partnership firm, partnership deed as the credential of the firm.
- (iv) In case of authorised dealer, the bidders shall attach the Valid Dealership certificate from the manufacturer of the brand of valves to be supplied in support of his credentials:
- (v) The bidder shall have executed/supplied Industrial valves and flanges to any Govt. /PSUs organizations in the order as specified below. The bidder shall also submit the completion certificate indicating satisfactory completion of the supply against the experience shown.
 - (a) A single order of not less than ₹. 50.00 lacs executed by the firm in the last 03(three) years and the bidder shall submit the copy of the said supply order. or
 - (b) Two orders of not less than ₹. 31.00 lacs each executed by the firm in the last 03(three) years and the bidder shall submit the copies of the largest supply orders or.
 - (c) Three orders of not less than ₹. 25.00 lacs each executed by the firm in the last 03(three) years and the bidder shall submit the copies of the largest supply orders.
- (vi) Copy of provisional/ migrated GST ID, PAN number, Bank account No (along with IFSC code) number should be submitted along with the Bid. The documents submitted

in support of the credential should be valid till the opening of the Bid as specified in the Tender.

(vii) The bidders shall attach the following in support of his credentials:

(a) In case of authorized Dealer - Valid Dealership certificate of the particular brand of the product to be supplied.

(b) In case of Manufacturers – License showing the firm to be manufacturer of the the to be supplied.

(viii) The bidder shall submit the general arrangement drawings of the materials to be submitted along with the Bid.

(ix) The Bidder shall indicate the brand of valves to be supplied in the prescribed format of the E-Tender.

b) FINANCIAL:

The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.

(i) Solvency certificate, not older than 6 months, by the firm from a nationalized / scheduled bank specifying the firm is financially sound to execute the contract amounting to ₹. 65.00 Lacs.

(ii) Annual turnover by the firm in the best three financial years out of last five financial year ending March 2018 should not be less than ₹. 90.00 Lacs.

c) Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 3.0 above shall be submitted along with the Techno-Commercial bid under Envelope – I,. Bids submitted without fulfilling the qualifying requirements shall be rejected.

d) The above requirements are minimum and the Corporation reserves the right to request for any additional information and also reserves the right to reject the proposal of any bidder if, in the opinion of owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to perform the work satisfactorily.

e) Notwithstanding anything stated above, the Corporation reserves the right to assess bidders' capability and capacity to supply the item, should the circumstances warrant such an assessment, in the overall interest of the Owner.

f) Each bidder shall submit only 1 (one) bid. A bidder who submits or participates in more than 1 (one) bid will be disqualified.

g) If an agent submits bid on behalf of one manufacturer/ dealer, the same agent shall not submit a bid on behalf of another manufacturer/dealer in the same tender

4. E-TENDERING / E-PROCUREMENT :

This tender is being processed through e-tendering/e-procurement system. The bidding documents are to be downloaded, filled in bids are to be submitted/ uploaded through e-tendering system of NEEPCO Ltd. at <https://neepco.abcprocure.com>.

5. PARTICIPATING IN THE BID:

5.1 Portal Registration:

The bidders intending to participate in the e-tendering and download the detailed bid document have to register themselves in the portal <https://neepco.abcprocure.com>. Relevant information about the bidder required during the registration is available in the portal.

5.2 Vendor registration fee: The fees for Vendor Registration in the portal is ₹. 3000.00(Indian Rupees three thousand) only per year (Non- Refundable). **Bidders who are already registered in the system shall ensure to keep their registration valid till completion of the entire bidding process.**

Bidders shall make payment of vendor registration fee of ₹. 3000.00 (Indian Rupees Three Thousand only) online through “SB Collect” detail procedure/steps is given in the Section II **Instruction to Bidders at Sl. No. 8.1.**

6. PROCEDURE FOR PAYMENT OF BID FEES & EMD:

6.1 Bid Fees

- a) Bidder shall make payment of non refundable Bid fees of amount ₹. 2360/- (**Rupees Two Thousand Three Hundred Sixty**) only inclusive of GST @18% online through “SB Collect” details of which is given in the Section-II **Instruction to Bidders at Sl. No. 8.2.** A copy of payment receipt to be uploaded in the e-tendering site falling which the bid shall not be considered. Further Documentary evidence of the Bid Fees paid shall accompany the Technical Bid. The invoice against the Bid Fee shall be submitted to the bidder after opening of the e-tender.
- b) Bids received online without Cost of Bid Documents shall be rejected.
- c) Please ensure that payment of Bid Fee is made under “RHEP PARTIES” only in SB Collect.

6.2 EMD

- a) Bidder shall make payment of refundable EMD of amount ₹. **1,25,000/- (Rupees One Lacs Twenty Five Thousand) only** online through “SB Collect” details of which is given in the section **Instruction to Bidder at Sl. No. 8.2.** A copy of payment e-receipt to be uploaded in the e-tendering site falling which the bid shall not be considered.
- b) Please ensure that payment of EMD is made under “**RHEP PARTIES**” only in SB Collect.
- c) Bidder may submit the EMD in the form of Bank Guarantee. In case of payment being made through Bank Guarantee from a Nationalized Bank duly covering the validity of the Bid in the prescribed format as given in the Section VI of the Bid Document. The **Original BG must be made available to the Tendering authority of RHEP, NEEPCO on or before 24.09.2018** in the address given below. A copy of the BG should be submitted along with the Technical Bid as a proof of EMD submitted.
