- (ii) Documentary evidence in support of experience with complete details of supply of similar nature executed in last 3 (three) years ending 31st March, 2012.
- (iii) Yearly turn-over for the last 3 (three) years supported by certified copies of audited Complete Annual Report and other financial statements for the preceding 3 (three) years. However relaxation of 3 years to 1 year may be allowed to the suppliers who have been qualified by the other CPSU's without fulfilling 3 years terms and also successfully completed the supply order issued by that Organization, subjected to

DETAILED TENDER DOCUMENT

1. GENERAL TERMS AND CONDITIONS:

1.1 **PRODUCT:**

Supply of Portland Slag Cement (PSC) confirming to, IS:455/1989 Alkali Content of Portland Slag Cement expressed as Na_2O in percentage plus 0.658 times the K_2O content in percentage i.e. $(Na_2+0.658K_2O)\%$ should be less than 0.6% to suit requirement of the Corporation, Ordinary Portland Cement (OPC-43 Grade) conforming to IS: 8112-1989 , Port land Pozzolona Cement (PPC) conforming to IS 1489/pt-1 (fly ash based).

1.2 **SCOPE OF WORK:**

The work against this Tender will include supply of approximately 25000 (twenty five thousand) MT of Portland Slag Cement (PSC), Portland Pozzolana Cement (PPC) and 43 grade Ordinary Portland Cement (OPC) in rake-load / part rake-load / or equivalent quantity in Truck/Trailer Load from the Suppliers' factory / go down to Tuirial Hydro Electric Project, Mizoram as shown in Schedule of Rate(s) under Annexure-I including arrangement of wagons / Truck / Trailer, loading & unloading and handing over the same to the consignee in good condition. For Schedule of Rate(s) under Annexure-II and Annexure-III, transportation of cement from Guwahati / Silchar Dump will be done by the Corporation at their own cost. However, Tax clearance, if any, for taking delivery of cement from the Supplier's Godown, shall be arranged by the supplier. Bidders quoting for Annexure-II & Annexure-III items should authenticate their bid for these items with documentary evidence of possession and location of Dump at Guwahati / Silchar, while quoting their rates as specified in.

Quantity indicated above is tentative. No extra claim for variation in quantity shall be entertained. Phase-wise procurement will be made against requirement.

1.3 **RATES:**

1.3.1 Bidders are to quote their rates per MT for different destinations as mentioned in the Schedules of Rates under **Annexure-I**, **II** and **III**, duly indicating Basic Price,

Excise duty, CST, freight and others separately as applicable. Road-way freight charges, as quoted, should be duly supported by authentic documents from the

concerned Authority. For inter-state supply, 2% CST will be applicable against issuance of 'C' forms by respective F&A Wing of end-use Projects. The rates should be inclusive of arrangement of loading, unloading, packing, transit insurance etc.

- 1.3.2 Accepted rate will be valid for 1 (one) year from the date of agreement. This validity may, however, be extended for a further period of 6 (six) months, if felt necessary by the Corporation.
- 1.3.3 <u>No conditional offers will be accepted</u>. Offers with any conditions, whatsoever, which are in deviation of the terms and conditions specified in this Tender Document shall stand summarily rejected.

1.4 THE POWER PROJECTS OF NEEPCO WHERE CEMENT WILL BE REQUIRED IS:

Tuirial H.E. Project, Mizoram.

1.5 **DELIVERY**:

Cement is to be dispatched to the specified Go down. Prior dispatch, information shall be handed over to the Consignee with intimation to the Office of the Executive Director (MM), NEEPCO Ltd., R.G.Baruah Road, Guwahati-781005, Assam at least 3 (three) days in advance from the arrival of cement at destination. Cement shall be dispatched against orders placed from time to time.

1.6 **VALIDITY OF BID:**

The Bids must be valid for acceptance for a minimum of 120 (one hundred twenty) days from the date of opening of Offers. Offers without this minimum validity period shall be liable for rejection.

1.7 **EARNEST MONEY DEPOSIT:**

Bids must be accompanied by Earnest Money Deposit (EMD) of Rs.5, 00,000.00 (Rupees five lakhs) only in the form of CDR/FDR/BANK DRAFT or BANK **GUARANTEE** (as per enclosed form in Annexure-IV), Nationalized/Scheduled Bank, pledged in favour of "NEEPCO LTD Guwahati". EMD will have to be deposited by all Bidders along with their Bids, irrespective of registration with DGS&D. Any Bid not accompanied by EMD will be liable for rejection. The EMD of the unsuccessful Bidders will be returned on drawal of Agreement with successful Bidder(s). EMD may be forfeited, if the Bidder(s) withdraw(s) its/their bid within the validity period. The EMD of the Successful Bidder will be released on submission of Contract Performance Guarantee as per clause No.1.21 of General Terms and Conditions and Signing of Contract Agreement.

1.8 **TEST CERTIFICATE**

Test Certificate(s) as per BIS specifications should be submitted along with dispatch documents for each consignment in triplicate.

1.9 PRICE ESCALATION:

Any statutory increase/decrease in Central Excise Duty, Railway Freight, Sales Tax after 28 days prior to the date of opening of Bids i.e. after 15.05.2012 will be paid / recovered against documentary evidence. However, the basic price of cement

shall be firm for the entire Contract Period and extended period, if any thereof and no escalation payment on this account will be entertained by the Corporation.

1.10 **TERMS OF PAYMENT:**

75% Payment shall be released on proof of delivery as per destinations mentioned in Annexure I, II & III against ordered quantity on submission of bills accompanied by test certificates. However in some exceptional cases part payment may be considered if the Corporation feels justified of the situation. Balance 25% shall be released upon receipt of satisfactory test results of the samples, collected jointly at destinations. The respective bills in triplicate shall have to be submitted to the consignee, the DGM (C)-I, TrHEP, Mizoram for effecting payments by The Sr. Manager (F),F & A Wing, TrHEP, Mizoram.

1.11 LOSSES OR DAMAGES IN TRANSIT:

- a) Supplier will be fully responsible for all losses / damages / shortages in transit up to destination of delivery. Payment will be effected only for the delivered quantity at destination in good condition. Suppliers or their authorized representatives will remain present at the time of delivery so that any damaged cement detected at destination i.e. at Project site or Godown will be replaced by them at free of cost. In absence of Supplier's representative at the time of delivery at Project site, the Corporation will store the damaged cement at Corporation's Godown. Cost of such handling and transportation will be recovered from the Supplier's bills, based on prevailing approved rates. The storage charge for storage of such damaged cement in Godown will be decided by the Project authority.
- b) During the process of taking delivery of cement by the consignee at Destinations, in the event bag(s) are found torn due to poor and inferior quality of bags or for any other reasons, the same will be rejected and value of quantity of cement in such rejected bags will be recovered from the suppliers bill(s). However, less damaged bags as would be found reasonable and within tolerable limits by the consignee at his sole discretion at the time of taking delivery will be accepted. The decision of the Corporation in this respect will be final and binding.

1.12 TIME OF SUBMISSION:

Bids must reach the Addressee before the time as specified in the Notice Inviting Bids i.e. before 1230 hrs. of 15.05.2012. **NEEPCO** will not be responsible for any delay of wrong delivery or non-delivery of Bids. Bids will not be accepted after the date and time as indicated in Notice Inviting Bids.

1.13 **PREPARATION OF OFFERS:**

Rates offered must be indicated by filling in the amount in figures as well as in words in the prescribed form in **Annexure I, II & III** of the bid documents. In case of differences, the amount indicated in words shall prevail and be binding. Apart from Bidder's signature, name, address and Official seal, no other remarks / conditions / stipulations should be entered by the Bidders on the Tender form. **All pages of the Bid Documents must be duly signed with seal.**

The rates must be in English and must be **FIRM.** No conditional offer will be accepted. Rates must be in terms of units as specified **in Annexure-I, II and III**_of the Bid Documents i.e. in Metric Tonnes for this Bid.

1.14 **WARRANTY / GUARANTEE:**

The goods to be supplied shall be of best quality and workmanship conforming to relevant BIS specifications and without any defect arising out of faulty materials, workmanship or design. Defective materials or part of materials returned / rejected by the Corporation shall be adjusted while releasing final payment, or shall be replaced at the expense of the Supplier. The Corporation's decision in the matter will be final and binding.

1.15 **PENALTY / LIQUIDATED DAMAGES FOR DEFAULT IN DELIVERY:**

The delivery period for supply will be the essence of the orders issued from time to time. In the event, the successful bidder fails to supply within the stipulated delivery period as indicated in the Supply Order without valid and convincing reasons, penalty will be levied to the extent of **o.5** (five) % per week subject to maximum of **15** (fifteen) % of the order value of the goods in respect of which the default in delivery takes place. The Corporation reserves the right to adjust liquidated damages either against the Performance Security Deposit or any amount that may be due or becomes due to the Supplier in any form.

1.16 **FORCE MAJEURE:**

- a) Within the stipulated Delivery Period, if delay has occurred due to "FORCE MAJEURE" conditions, which are beyond the control of the Supplier, payment of penalty as per clause 1.15 by the Supplier to NEEPCO LTD. on account of delay in delivery may be waived at the discretion of the Executive Director (MM), NEEPCO Ltd. R.G.Baruah Road, Guwahati-781005, Assam. The Supplier shall, however, apply to the Executive Director (MM), NEEPCO Ltd. R.G.Baruah Road, Guwahati-781005 for waiver of payment of Penalty/Liquidated damages in such cases, supported by documentary evidence of such occurrence. Decision of the Corporation as regards to acceptance of the reasons stated by the Supplier vis-à-vis imposition of penalty is final and binding on the Supplier.
- b) The term "Force majeure" shall mean riots (other than among the Supplier's employees), civil commotion (to the extent not insurable), war (whether declared or not), invasion, act of foreign enemies, hostilities, civil war, rebellion, revolution, insurrection, military power, damage from air craft, nuclear fission, acts of God such as earthquake (above 7 magnitude in Richter Scale), lightning, unprecedented floods, fires, not caused by Contractor's negligence and other such causes over which the Supplier has no control and are accepted as such, by the Competent Authority, whose decision shall be final and binding. In the event of either party being rendered unable by force majeure to reform any obligation required to be performed by them under this contract, the relative obligation of the party effected by such force majeure shall be treated as suspended for the period during which each Force majeure cause lasts, provided the party alleging that it has been rendered unable as aforesaid, thereby shall notify within 10

(ten) days of the alleged beginning and ending thereof giving full details / particulars and satisfactory evidence in support of such cause.

1. 17 **ARBITRATION:**

In the event of disagreement / disputes arising in connection with execution of the order when place, which cannot be settled in an amicable manner between the supplier and the Corporation, the matter shall be referred to arbitration. Such arbitration shall be governed by the provisions of the Indian Arbitration Act, 1940, Arbitration & Conciliation Proceedings Act, 1996 as amended from time to time or any statutory modification or reenactment thereof for the time being in force. The venue of such arbitration will be Guwahati.

Any dispute arising out of this tender will be subjected to the jurisdiction of the Court of the District Magistrate, Guwahati, Assam.

1. 18 **SELECTION OF OFFERS:**

The Corporation reserves the right of accepting the whole or any part of the bid or portion of the quantity offered and to select one or more bidder. The selected bidders shall supply cement strictly of required specification as mentioned in this bid document at the rates finally approved by the Corporation. The Corporation also reserves the right to reject any or all bids without assigning any reasons thereof. The Corporation is not bound to accept the lowest bidder.

1. 19 **ELIGIBILITY FOR PARTICIPATION IN BID:**

As per Clause No. 6 of Notice Inviting Bid.

1. 20 INCOME TAX AND SALES TAX REGISTRATION CERTIFICATES:

Copies of latest Income Tax Clearance Certificate or PAN and Sales Tax Registration Certificate shall have to be enclosed with the Bid.

1.21 SECURITY DEPOSIT/CONTRACT PERFORMANCE GUARANTEE:

Total amount of Security Deposit / Contract Performance Guarantee for successful Bidders will be Rs. 5,00,000.00 (Rupees Five lakhs) only in the form of Bank Guarantee in prescribed format from any Nationalized or Scheduled Bank in India / Fixed Deposit / Call Deposit pledged in favour of North Eastern Electric Power Corporation Ltd., Guwahati. Bank Guarantee format for Security Deposit is enclosed at Annexure-V. Bank Guarantee furnished shall remain valid for the entire contract period and for a further period of 3 (three) months beyond the contract period. In case, contract period is extended, the supplier shall extend the validity of BG(s) for the extended period of contract and for further 3 (three) months from the extended period of contract.

2. TERMS OF QUALITY ASSURANCE:

2.1 The various types of Cement to be procured shall be utilized mainly in major hydraulic structures / important Civil Engineering structures such as Dam, Tunnel, and Power House etc. in the Power Project under execution by **NEEPCO.** As such the quality of Cement to be supplied needs to conform strictly to the specifications mentioned herein without any compromise whatsoever. For any

- deficiency in quality of cement in terms of strength etc. as per BIS standards, as determined during testing of cement from the samples collected by the Quality Control Wing of the Corporation at the time of taking delivery at destinations, the Supplier will replace the defective cement with good quality cement at their cost or will refund the cost of the defective cement to NEEPCO.
- PSC (Portland Slag Cement) must conform to relevant BIS Codes and its total Alkali Content expressed in terms of Sodium Oxide and Potassium Oxide, i.e. (Na₂O+o.658K₂O) in percentage must be below o.6%. The Slag content of cement should also be within the stipulated limit as per relevant BIS specifications. Where cement (PSC) is supplied, test certificates required, as per para 1.8 should also contain the total value of Na₂O and K₂O as per the same para. 33 Grade Ordinary Portland Cement (OPC) conforming to IS-269, Ordinary Portland Cement (OPC-43 Grade) IS: 8112-1989, Port land Pozzolana Cement (PPC) conforming to IS 1489/pt-1 (fly ash based).
- 2.2.2 Cement must be packed in best quality HDPE bags conforming to IS: 11652-2000.
- 2.3 For the information of the manufacturers / suppliers of cement, it is mentioned here that the procedures followed by the Corporation for sampling and testing of cement received by **NEEPCO** are as given below:
- 2.3.1 Laboratory samples of cement will be collected by the Quality Control Wing of the Corporation on arrival of the materials at Supplier's Godown / TrHEP site as per IS: 3535/1966, jointly in presence of representatives (s) of the supplier, transporter and Corporation's Officials for Laboratory testing in NEEPCO's own testing Laboratory and in any other Govt. approved laboratory or other laboratory approved by the BIS. The test results thereof shall be binding and final in terms of Para 2.1.
- 2.3.2 Considerable time is taken for transportation of Cement to Project site of the Corporation located in remote area from the Supplier's Godown. As such, it is preferable that initial strength of cement as per test results, should be substantially higher than the permissible limits as prescribed in relevant BIS Codes. This will be taken into account by the Corporation, after observing the test results of cement supplied by various manufacturers for placement of Orders for supply of Cement. It will also be necessary that all manufacturers/Suppliers will ensure supply of only fresh Cement to the Corporation during the entire validity period of the Contract, duly making the date of manufacture, as required for BIS certification. Supply of Cement from Dump/Godown of Suppliers at intermediate locations should be avoided as far as possible, other than emergent shall suppliers, where also the above-mentioned quality assurance shall be ensured strictly by the Supplier.
- 2.3.3 After the Cement is transported to the respective Project sites from Supplier's Godown, samples of cement are again collected progressively as per **IS:** 3535.1966 and are tested in the Project Testing Laboratories of the Corporation before these are used in the works.
- 2.3.4 In case of observance of inferior test results, besides taking action as indicated in Para 2.1 above, the matter may be reported to **BIS**, considering the merits of the

case, for their further action. In this regard, it may be noted by all the bidders that only **BIS** marked cement will be accepted by the Corporation.

2.4 The authorized local representative of the Supplier shall be deputed to the destinations at the time of taking delivery of cement, so that laboratory samples of cement can be taken by the Quality Control Wing of the Corporation in his presence. However, in case the authorized local representative is not available at that time, inspite of informing him over phone, the samples will be collected by the Quality Control Wing of the Corporation in presence of Officials of the Corporation and authorized transporters, and the test results obtained thereof will be binding and final upon the Supplier.

3. OTHER TERMS AND CONDITIONS:

3.1 **SUBMISSION:**
