- 2) **Closing and opening of tender**: Tenders shall be received up to 13:00 hrs. on **09.07.2012** and shall be opened at 15:00 hrs. on the same day (**09.07.2012**), in presence of Contractors or their authorized representative(s) .In the event of holiday the tender shall be received and opened on the next working day at the same time and place.
- 3) **Experience**: Experience for execution of similar type of work is necessary.
- 4) **Issue of store materials**: No materials will be supplied from the Department.
- 5) **T&P**: No T&P will be provided from the Department.
- 6) **Estimated amount**: The estimated amount is inclusive of Building Cess and Works Contract tax and Transportation Charges. Deduction from gross work value, against Building Cess and Works Contract Tax will be made @ 1% and 4% of gross work value respectively.

**7) Documents required for obtaining Tender Paper :**

- i) Certified copy of EPF registration along with up to date Challan against remittance towards EPF.
- ii) Copy of VAT registration.
- iii) Certified copy of registration with NEEPCO, RHEP, Yazali (A.P) in case of RHEP registered contractor in addition to document mentioned in 7(i) above.
