1. **RESERVED PRICE OF THE VEHICLE IS Rs.1,19,394.00 (Rupees One Lakh Nineteen Thousand Three Hundred Ninety Four)only**
2. The bidder should quote his price in the prescribed form as per Annexure – I.
3. The rate quoted must compulsorily be excluding lifting, labour and transporting charges which will be born by the party at their own cost at the time of lifting of the disposed vehicle as per approval. Similarly the quoted rate will not include sale taxes payable to the State Sale Tax Department.
4. The vehicle should be taken delivery only after full payment in the shape of D.D. drawn in favour of NEEPCO Ltd., Guwahati payable at Guwahati.
5. The sealed tenders superscribing tender notice no. should be addressed to Sr.Manager(C) Coordination, NEEPCO Ltd., Guwahati. The tenders received in unsealed covers will be rejected.
