- 1.0 This invitation for bids follows the procurement notice (Invitation for Bids) for the subject package(s) which will appear in National and Regional Newspapers on 11.02.2014. This shall also be available on [www.neepco.gov.in](http://www.neepco.gov.in) & <http://neepco.abcpurchase.com> from 11.02.2014.
- 2.0 North Eastern Electric Power Corporation Ltd (hereinafter referred to as 'NEEPCO Ltd.') have been entrusted to execute the Project i.e. Rural Electrification works of Shipahijala district in Tripura under Rajiv Gandhi Grameen Vidyutikaran Yojna (RGGVY)-12th Plan on behalf of Tripura State Electricity Corporation Ltd /Government of Tripura. The execution of the project shall be funded out of the proceeds of financial assistance to be received by Government of Tripura from Rural Electrification Corporation Limited (REC) and the ownership of the project shall remain vested with Government of Tripura. The project shall be executed by NEEPCO Ltd on turnkey basis and all eligible payment under the project shall be made from the proceeds of financial assistance to be received by Government of Tripura. For the purpose of all procurement activities related to the aforesaid project, NEEPCO Ltd. shall be referred to as 'Employer' and Government of Tripura "the Owner"
- 3.0 NEEPCO Ltd., therefore, invites sealed bids from eligible bidders for the following package(s) for aforesaid project on Domestic Competitive Bidding basis:

This Invitation for Bids extended through media, website or written communication or by any other means, and issuance of Bidding Documents as per para 7.0 below shall not be construed to mean that the prospective bidders to whom the Invitation for Bids has been extended and/or Bidding Documents have been issued is deemed to be an eligible bidder. The eligibility of the bidders shall be determined as per the provisions of Bidding Documents.

3.1 This Specification covers the following scope of works:

The scope of work under the subject package includes site survey, planning, design, engineering, assembly manufacturing, testing, supply, loading, transportation, unloading, insurance, delivery at site, handling, storage, installation, testing, commissioning and documentation of all items/material required to complete the Rural Electrification works in Shipahijala district which inter-alia include construction of New 66/11 kV Substation, 33/11 kV substation, 33 kV bay extension, construction of 66 & 33 kV lines, 11 kV & LT line, Installation of distribution transformer and providing service connection to BPL consumer spread all over the district.

The above scope of work is indicative and the detailed scope of work is given in the Bidding Documents.

3.2 The completion period for Rural Electrification works of Shipahijala district in Tripura under Rajiv Gandhi Grameen Vidyutikaran Yojna (RGGVY) shall be the period as specified in Instructions To Bidders(ITB) Sub-Clause 24.1(c).

3.3 Bidding will be conducted through the domestic competitive bidding procedures as per the provisions of ITB/BDS (Bid Data Sheets) and the contract shall be executed as per the provisions of the Contract.

4.0 The detailed Qualifying Requirements (QR) are given in the Bidding Document.

5.0 The complete Bidding Documents including tender drawings and technical specifications are available at NEEPCO's website <http://neepco.abcpurchase.com>, <http://www.neepco.gov.in>. Interested bidders can download the Bidding Documents and commence preparation of bids to gain time.

6.0 Interested eligible bidders may obtain further information from and inspect the Bidding Documents at the office of Executive Director, C&P at the address given at para 11.0 below from 10.00 hours (IST) to 17.00 hours (IST) on all working days till the sale of Bidding Documents is open as per para 7.0 below.

7.0 Interested Bidders will be required to download the Bidding Documents from <http://neepco.abcpurchase.com>, after registration & payment of vendor registration fee of Rs.3000/- ( Three Thousand) only per year and payment of Bid Document fee of Rs 10,000/- ( Ten thousand) only . Details for registration & for payment of Bid Document fee is as per Para 9.0. Bid should be submitted along with scanned copy of the payment receipt towards the cost of Bid Document and Bank Guarantee towards Bid Security towards Earnest Money failing which, the tender shall be summarily rejected.

The Bidding Documents are meant for the exclusive purpose of bidding against this specification and shall not be transferred to any other party or reproduced or used otherwise for any purpose other than for which they are specifically issued.

8.0 A pre-bid meeting will be held at the office of the Employer at Agartala Gas Turbine Plant, NEEPCO Ltd, Ramchandra nagar, Tripura( West) on 26/02/2014 at 11-00 hrs to clarify the bidders various issues raised in accordance with clause 6.4 of ITB.

9.0 A Single Stage Two Envelope Bidding Procedure will be adopted and will proceed as detailed in the Bidding Documents.

9.1 Participation in Bids

Price Bids shall be submitted electronically only. Late bids will be rejected.
