2. BIDDING PROCEDURE:

3.0 CREDENTIALS OF THE BIDDERS TO BE FURNISHED:

Bidders are to submit the following particulars in support of the Qualifying Requirements.

(i) Only manufacturers, their authorized dealers/ representatives having sufficient experience of similar works, shall be allowed to quote for the works. Similar works are defined as the works of supply, installation, testing, commissioning and maintenance of automatic data acquisition sensors for collection of hydro-meteorological data through sensors, its collection with hardware, software. The bidder shall be required to produce proof from the appropriate authorities of having satisfactorily completed similar works during the last ten years (ending on the last day of the month previous to the one in which the tenders are invited), where the systems installed by them are working satisfactorily. Such works could be inspected.

The bidder shall have to fulfill the following criteria of satisfactory execution of works as given below;

a) Two similar works, each of value not less than 50% of the estimated cost, or one similar work of value not less than 80% of the estimated cost put to tender, during the last ten years (ending on the last day of the month previous to the one in which the tenders are invited), where the systems installed by them are working satisfactorily.

And,

b) Having annual turnover equivalent of Indian Rs. 50 Lakhs each during last consecutive three years. Copies of audited balance sheets of the company shall be provided while purchasing tender documents.

And,

c) Having successfully and satisfactorily maintained automatic data acquisition system for at least two years during last ten years as in para a) above.

And.

- d) Having office for post sale services in North East India. Documentary proof for existence of office for post sale services in North East India shall be provided by the bidder while purchasing tender documents.
- ii) Copies of latest Income Tax Clearance Certificate or PAN and Sales Tax Registration Certificates shall be provided by the bidder while purchasing tender documents.

However, the issue of tender forms does not mean that bidder meets all the qualifying requirements and in case, if any bidder was found to be not meeting the specified qualifying requirements, his/ her tender would be summarily rejected and the bidder shall have no claim on refund of the cost of tender document in such a case.

Bids submitted without fulfilling the qualifying requirements shall be outright rejected. Price Bids of those Bidders shall only be opened, who fulfils the minimum qualifying requirements as indicated under Serial No. 3 above and have submitted the requisite EMD in the manner prescribed in the Bid Documents. The date of opening of Price Bids will be intimated later on to the bidders who will be selected in techno commercial Bid. Price Bids of un-successful Bidders, who fail to demonstrate the minimum qualifying requirements, shall not be opened and the EMD in that case shall be returned immediately after opening of Price Bids.
