NEEPCO invites Sealed Single-Stage Two Envelope Bids through Domestic Competitive Bidding route from eligible bidders for Manufacture, Inspection and Testing at Manufacturer's works before despatch, Packing & Forwarding, Supply, Transportation to site, handling and freight, Insurance from the source of supply till receipt at site of LED luminaires for O&M plants of NEEPCO, complete in all respects.

Qualifying Requirement for Bidders:

1.0 Technical capability :

- a. The bidder shall be an Indian manufacturer having in-house technical competence and product development capability and who are categorised as Micro, Small and Medium Enterprise.
- b. The Bidder shall have successfully supplied similar equipment in any Public Sector Undertaking/ Government (either Central or State Government) Organisation in India during last 5 (five) years ending last day of the month previous to the one in which the NIB is floated as under:
 - i. At least 3(three) completed similar works, each of value not less than Rs. 3,91,49,338.00 ; OR
 - ii. At least 2(two) completed similar works, each of value not less than Rs. 4,89,36,673.00 ; OR
 - iii. At least 1(one) completed similar work of value not less than Rs. 7,82,98,676.00

'Similar work' means supply of LED lamps and fittings. The bidder should furnish copies of detailed orders and also performance certificates from the customers, which should indicate the dates of successful execution.

- c. Bidder should have full fledged service Set-Up(s)/ Service Centre(s) of its own or authorized service agent in North East India. Details of such Set-Up(s)/ Service Centre(s) indicating complete address, names of persons and contact details shall have to be furnished. In case service is rendered through Authorised Service Agent, the bidder shall furnish a certificate indicating the name and place of Service Set-Up(s) / Service Centre(s) of such agent. The bidder shall furnish customer feedback details against services provided

2.0 **Financial Capability:**

(a) Minimum Average Annual Turn Over (MAAT):

The average annual turnover of the bidder in the best 3 (three) financial years out of the last 5 (five) financial years should not be less than Rs. 19,57,46,690.00. Other income will not be considered for arriving at annual turn over.

(b) Net Worth:

The Net Worth of the bidder as on last day of the preceding financial year shall not be less than 50% of the Paid up Share Capital.

The Net Worth shall be calculated based on Subscribed and Paid-up Capital + Free Reserves + Unallocated balance surplus amount of Profit & Loss Account if not reduced from Reserves.

Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account & detailed Schedule and other financial statements for the preceding 5(five) financial years, ending 31st March of the previous Financial Year, along with Letter of adequacy and commitment from their Bankers/Financial Institutions of International repute should be furnished along with their bids for evaluating the above financial criteria. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable.

(c) Liquid Assets:

The bidder should have liquid assets or / and evidence to availability of unutilized credit facilities of not less than Rs. 4,07,80,560.00

The certificate of the Banker regarding the availability of unutilized credit facility should not be dated earlier than 30 (thirty) days prior to the date of opening the bid.

(d) Bid Capacity:

The available Bid Capacity of the Bidder at the time of submission of Bid, calculated as under should not be less than the estimated cost of the work put to tender:

Bid Capacity = $A \times N \times 2 - B$, where,

A = maximum value of works executed in any one year during last 7 (seven) years (at current price level).

N = Completion time of the proposed work in years.

B = Value at current price level of existing commitments and on going works to be completed during next N years.

Bids submitted without fulfilling the qualifying requirements shall be rejected.

4.1 Portal Registration:

4.2 Vendor registration fee:
