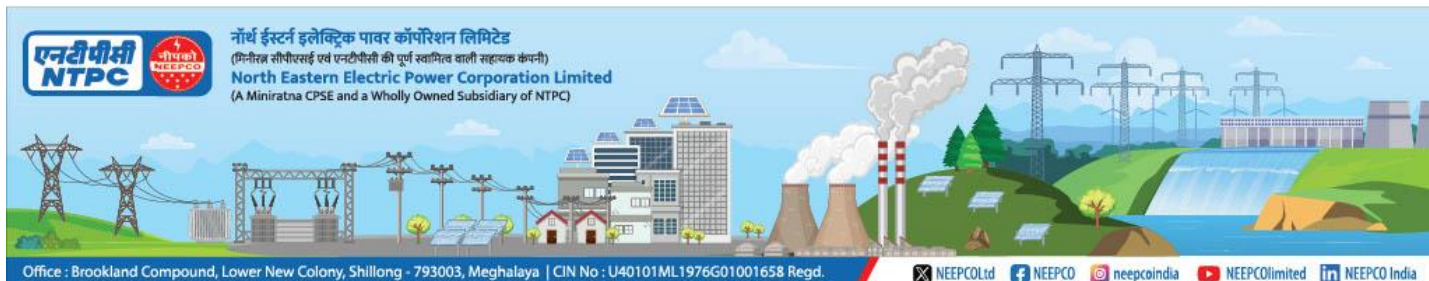

- 2) **The applicant should have registered his/ her name in any one of the Employment Exchange detailed as under:**
  - (a) Duliajan Employment Exchange OR (b) Shillong Employment Exchange, East Khasi Hills District.
- 3) **Only the candidates who have completed B.Com with Accountancy and Auditing as subjects + ICAI (Inter)/ ICWA (Inter) from a recognized University, Valid Registration Card of Duliajan Employment Exchange or Shillong Employment Exchange, Permanent Residential Certificate issued by Government of Assam or Meghalaya should apply for the post.**

- e) A certificate of Conversion of grade/CGPA to percentage of marks shall be based on the procedure certified by the University/Institution from where they have obtained the Bachelor Degree.
- f) Recent passport size colour photograph (JPEG, Size 20 KB up to 100KB)
- g) Signature (JPEG, Size 20 KB up to 100KB)
