Dear Colleagues,

I wish you and your families a very happy and prosperous 2022. On this festive and joyous occasion of the New Year, it gives me immense pleasure to convey to each one of you my best wishes for happiness, success and prosperity.

Despite the challenges of COVID19, your corporation did not stop working for a single day and ensured uninterrupted supply of electricity. We have commissioned the 600 MW Kameng Hydro Power Project with the concerted efforts of all the employees. The historical problems in Kameng have been diagnosed and being rectified through the leading company of the world. This Plant is slated for dedication by the Hon'ble Prime Minister of India shortly.

After Quarter-3 of FY21, NEEPCO has achieved many new landmarks which are highest ever in the last 46 years of its history. Up to the third quarter of 2021-22 we have achieved a generation of 6690 MU; our turnover has reached Rs. 2558 crores; and profit before tax (PBT) has been Rs. 491 crores. Many vital policy initiatives taken by NEEPCO in rationalization of transmission charges will make these future hydro projects lucrative and will lead to our sustainability.

I would request with utmost sincerity to everyone not to get carried away with rumors being spread by some vested interests to monopolize the organization for their own selfish agenda. Through this communication I wish to categorically assure each and every one of you that the management does not have any plan whatsoever to retrench any category of employee whether it is regular or work charged. Whatever organizational strength or structure is recommended to be achieved is planned to be achieved only through natural retirements and not through retrenchments as is being misled by certain vested interests.
