Dear Sir(s),

With reference to communications as mentioned above in references, we have noted representations made by your insurance company i.e. Go Digit General Insurance Ltd. You have given explanation about inadvertent unintentional error in the bid submission for Bid No. GEM/2025/B/5816535 Dated 15.01.2025. Further, you have also assured us by submitting an undertaking vide letter Dtd. 02.12.2025 that your company will not participate in any tenders issued by NEEPCO for the full duration of the two-year suspension period starting from 12.03.2025 and ending on 11.03.2027.

Considering the explanations submitted by you and your commitment to not bid/participate for any tenders of NEEPCO till 11th March, 2027, the notice of suspension issued to your company vide letter No. NEEPCO/QP/ED/C&P/F/DHEP-391/2024-25/2628 Dated 12.03.2025 is revoked subject to the following conditions.

1. That this revocation is made strictly subject to and conditional upon adherence of your company to the undertaking furnished, ensuring non-participation in any tenders issued by NEEPCO for the entire period from 12.03.2025 to 11.03.2027. Any breach of this undertaking shall render this revocation null and void, and the original suspension shall be reinstated with immediate effect, and violation of the same will be liable to actions as per the policy and rules of NEEPCO.
2. It is also stated that any such revocation of suspension shall not act as a precedent for future request by you/any other company/ stakeholder. The sole prerogative rests with NEEPCO's management as per rules and internal policies.
