With reference to above, I am pleased to inform you that the North Eastern Electric Power Corporation Limited (NEEPCO) intends to award you the work of "Construction of 2(two) Nos. of Raw Water Reservoirs and another 2(two) Nos. of Clear Water Reservoirs for Water Treatment Plant at Doyang Hydro Electric Plant, Doyang, Nagaland" as per scope, terms and conditions of the Bid document for a Contract Price of Rs. 2,15,93,805.00 (Rupees two crore fifteen lakhs ninety three thousand eight hundred and five only) including all applicable taxes & duties.

The time of completion for the entire scope of work is 6(six) months from the date of issue of Letter of Intent (LOI).

In terms of Clause 5.4 of Part-III, Clause 27 & 41 of Part-IV of Bid Document, you are requested to submit the following to the Head of Plant, Doyang Hydro Electric Plant, NEEPCO Ltd., Doyang, Wokha District, Nagaland, PIN- 797100 India, within 15 (fifteen) days from the date of issue of LOI, for his approval. The same shall form an integral part of the Contract Agreement.

- (i) Work Programme and Mobilisation Plan, showing the procedure proposed to be adopted to carry out and complete the work in all respect within the stipulated time of completion.
- (ii) Quality Assurance Programme (QAP) in terms of Clause 46, Part-4 of the Bid Document.

In terms of Clause 5.5, Part-III of Bid Document, an Initial Security Deposit (ISD) equivalent to 1% (one percent) of the Contract Sum i.e. for an amount of Rs. 2,16,000/- (Rupees two lakhs, sixteen thousand only)



shall be submitted by you in the form of Bank Guarantee as per the prescribed format provided in Annexure-B of Part-III of Bid Document, within 15(fifteen) days from the date of issue of the LOI.

It may be informed that until a formal Contract Agreement is executed, the LOI, DWO read in conjunction with the NIB, Bid document will constitute a binding Contract between the Contractor and the Owner in terms of Clause 5.3(ii), Part-III of Bid Document.
