1. Scope:

The Scope of Supply and Services under the Contract will be as given below:

- a. Detailed Design and Engineering, Manufacture, Testing at Works, Despatch, Inland Transportation including Freight and Insurance, Delivery to Project Site, Unloading and Handling at Site, Comprehensive Insurance for taking care of eventualities till Handing Over of the Plant/Work, Storage and Preservation of Equipment at site or any intermediate locations, Erection, Testing and Commissioning at site of Electro-Mechanical Equipment along with all station auxiliaries to be installed in Khandong Power Station (2x23MW), Assam, India.

The detailed scope of work shall be as per Technical Specification, Sec-IV of Technical document published as part of the Detailed Bid Document to be read in conjunction with Corrigenda and Pre-Bid Clarifications issued by NEEPCO thereon.

2. Contract Price:
