Dear Sir,

With reference to the above, The North Eastern Electric Power Corporation Limited (hereinafter referred to as the "Corporation" is pleased to place this Detailed Work Order with you (hereinafter referred to be as the "Contractor" for execution of the above mentioned work as per scope, terms & conditions stated below. The BOQ items & rates shall be indicated at Annexure-I (Bill of Quantity) enclosed with this order.

Terms and conditions:

- 1. Scope of work: The scope of works shall include Dismantling, Loading on Trucks, shifting to designated area, unloading and stacking of Electro-Mechanical Equipment of Khandong 2x25 MW Power Station complete in all respect as per Technical Specifications, Bill of Quantities (BOQ) following the provisions stipulated in the above referred NIT, bid documents and as per direction of engineer in charge. The quantities of different item of works as indicated in the enclosed Annexure-I (BOQ) are tentative and may undergo changes as per actual requirement at site.
- 2. <u>Contract Price</u>: The total value of contract is Rs. 1,29,17,530.00 (Rupees One Crore Twenty Nine Lakh Seventeen Thousand Five Hundred Thirty) only, excluding GST.
- 3. Completion time: Time of completion for the work is 60 (Sixty) Days from the date of issue of this order.
- 4. <u>Taxes & Duties:</u> The contract price of work as indicated is exclusive of applicable GST, which shall be extra at actual.
- 5. Compensation for delay in Completion:- The time allowed for carrying out the work as stipulated in the contract or any ex-tended period (not due to the fault of the contractor) as may be allowed shall be strictly observed by the contractor and shall be reckoned from the date on which order to commence work is given to the contractor. The work shall throughout the stipulated period of the contract be proceed with all due diligence, time being the essence of the contract on the part of the contractor. The contractor shall be liable to pay as compensation @0.5% of Contract Amount per week of delay, subjected to a maximum of 10% of the whole Contract Amount. In any case the decision of the Engineer-in-Charge in this regard is final and binding to the contractor.

6. Performance Security/ Security Deposit (SD).

6.1 The full amount of Bid Security deposited by the successful bidder along with his bid may be converted into Performance Security (Initial Security Deposit, ISD), that will be treated as part of the Security Deposit. Security Deposit will be 3 % (Three percent) on the total value of the work actually executed inclusive of escalation and value of extra works etc. 03 % (Three percent) Security Deposit, after I.S.D becomes 03 % (Three percent) of executed work value, will be deducted from every interim payment made on account of this work for the due performance of the Contract under the terms and conditions laid in the Contract, which shall include all works

payment, escalation payment and any other payment made to the Contractor for the work during the period of Contract.

- 6.2 If the Contractor expressly requests in writing, he will be permitted to convert the amount of Security Deposit deducted from his Bills into Bank Guarantee (BG) of any Nationalised / Scheduled bank in the country of the Corporation or a foreign bank confirmed by State Bank of India, London or New Delhi main Branch in the prescribed form. The amount of SD to be converted shall not be less than 1% of Contract Sum at a time. The validity period of such BG shall initially be 90 days beyond the schedule date/ revised scheduled date of completion of defect liability period.
- 6.3 Within 21 (twenty One) days from the date of issue of Letter of Intent / Award, the Contractor shall furnish a emdarantee for an amount equal to (3%) three percent of the contract value (i.e. valid until the expiry of 90 (ninety) days from the date of expiry of defects liability period or until the Contractor has executed and completed the works and remedied any defects therein, in accordance with the Contract, whichever is later.) by way of guarantee for the due and faithful performance of the contract, in any of the following form:
 - a) An irrevocable bank guarantee issued preferably by any Indian Nationalized Bank in favour of North Eastern Electric Power Corporation Limited in the prescribed format.
- 6.4 The Bank guarantee shall be initially valid for such period to cover upto Ninety days after the expiry of the contractual period as per Agreement. The bank guarantees against Security Deposit Shall be issued either by a nationalized Bank/Scheduled bank in the country of the corporation or a foreign bank confirmed by State bank of India, London or New Delhi Main Branch. The Performance Security of a joint Ventures Shall be submitted by the respective joint venture partners in proportion to their participation share in the joint venture. The bank guarantee format is given in Section V: Form B of this bid document.
- 6.5 The Performance Guarantee will be returned to the Contractor without any interest after expiry of the contract, subject to fulfillment of the work in all respects and no outstanding are to be recovered from the contractor.
- 6.6 It is expressly understood and agreed that the amount of Performance Guarantee shall not be construed as limiting factor/amount for various liabilities under the contract.

7. Payment Terms:

General: The payment to the contractor for performance of works under the Contract will be made by the Corporation as the guidelines and conditions specified herein.

Terms of Payment:

- i. Interim bill shall be submitted by the contractor monthly on or after the date fixed by the Engineer-In-Charge for the executed work. The Engineer-In-Charge shall then arrange to have the bill verified with reference to the measurements recorded in the measurement book(s).
- ii. Payment on account for the amount admissible shall be made by the Engineer-In-Charge certifying the sum to which the contractor is considered entitle by way of interim payment for the work executed, after deducting the amount already paid, the security deposit and such other amount deductible in terms of the contract. Advance payment, if any, made on account of this contract shall be deducted from interim bills.
- iii. Payment of the contractor shall be made by the Corporation within 30 (thirty) days from the date of submission of bills subject to the acceptance of the bills by the Engineer-In-Charge.
- 8. Extra work/ substitute item: In case extra work/substitute item are required to be executed for successful completion of the work the contractor shall execute the same and rate shall be decided mutually.
- 9. Paying Authority: The Paying Authority would be DGM (F), KHPS NEEPCO Ltd. Umrongso.


