With reference to above, the North Eastern Electric Power Corporation Limited (hereinafter referred to as the "Corporation") is pleased to place this Letter of Award (LOA) for the above-mentioned work, with M/s GNP Enterprise, District- West Siang, Arunachal Pradesh-791001 (hereinafter referred to as the "Contractor") as per scope, terms & conditions of the NIB No. NEEPCO/HOP/TTH/2025-26/08 Dated 07-01-2026, Bid document, Corrigendum issued thereto.

The salient Terms and Conditions are mentioned below for reference:

**1. SCOPE OF WORK:**

The overall scope of work covered under this Contract comprises of "Construction of Paver Block Apron in the Office Complex of Divisional Forest Officer (DFO), Along Forest Division, Aalo, Arunachal Pradesh", complete in all respect, as indicated in Clause 2, Part-1 (Detail NIB) of Bid document.

The quantities of different items of works, as indicated in the Bill of Quantities (BOQ) enclosed at Annexure-I are tentative and may undergo changes.

The cost of materials and components not specifically stated in any items of BOQ but are necessary for satisfactory completion of the said item of works as per Technical Specifications in all respect, shall be deemed to have been included in the scope of work, for which no extra claim shall be entertained by the Corporation.

**2. TIME OF COMPLETION:**

The time of completion for the entire scope of work is 45 (Forty-Five) days from the date of issue of Letter of Acceptance (LOA).

In terms of Clause 34, Part-2 (Instruction to Bidders) of Bid document, the Contractor shall submit the following to the Engineer-in-Charge i.e. DGM (Tech) or his authorized representative(s), Heo H.E.

- Work Programme indicating the sequence of various activities and the order of procedure in which he proposes to carry out the awarded work in all respect within the stipulated time of completion.
- Mobilization schedule of manpower.
- Mobilization schedule of plants & equipment.
- Quality Assurance Plan (QAP) for the said works.

The Contractor shall strictly adhere to such Approved Work Programme, Mobilisation schedules and Quality Assurance Plan (QAP).

**3. CONTRACT PRICE:**

The Contract Price is **Rs. 20,00,380.16 (Rupees Twenty Lakh, Three Hundred, Eighty and Paise Sixteen only)** including all applicable taxes, cess etc. as indicated in the BOQ enclosed at Annexure-I.

**4. TAXES, DUTIES, LEVIES ETC.:**

The rates as indicated against various item of works in the BOQ are inclusive of all applicable taxes, duties, levies, cess etc. existing 28 (twenty-eight) days (i.e. 29-12-2025) prior to latest date of submission of bids (i.e. 26-01-2026). In this regard, provisions of Clause 11, Part-2 (ITB) & Clause 61, Part-3(Conditions of Contract) of Bid Document shall prevail.

**5. TERMS OF PAYMENT:**

The payment to the Contractor for the works executed under the Contract shall be governed by the provisions of Clause 52, 53, 54 & 55, Part-3 (Conditions of Contract) of Bid document.

**Paying Authority:** All payments shall be made by the Head of Finance, F&A, Heo H.E. Project, NEEPCO Ltd., PO: Tato, Dist.: Shi Yomi, Arunachal Pradesh-791003, who shall release the payment based on certification by the Engineer-in-Charge.

**6. PRICE ADJUSTMENT / VARIATION:**

The rates indicated in the BOQ under the contract are firm. No price adjustment in respect of any item of work for any variation (increase / decrease) in cost of Labour, Materials and High Speed Diesel including taxes, duties, levies, cess, etc. shall be admissible against the Contract, as per the provisions of Clause 72, Part-3 (Conditions of Contract) of Bid document.

**7. COMMENCEMENT OF WORK:**

The work shall be started within 7(seven) days from the date of issue of Letter of Acceptance, as per the provisions of Clause 27, Part-3 (Conditions of Contract) of Bid document.

9. **POWER SUPPLY:**

The supply of power for the Contract shall be governed by the provisions of Clause 50, Part-3 (Conditions of Contract) of Bid document.

10. **LABOUR:**

The Contractor shall employ labour for execution of the work as per the provisions of Clause 35, Part-3 (Conditions of Contract) of Bid document.

11. **CONSTRUCTION PLANT AND EQUIPMENT:**

The Contractor shall deploy all required plant, equipment and machinery in good and running condition for execution of the work as per Clause 41, Part-3 (Conditions of Contract) of Bid document.

12. **CONSTRUCTION MATERIALS:**

The Contractor shall arrange and supply all materials required for the works, at his own expense, as per provisions of Clause 31, Part-2 (Instruction to Bidders) and Clause 48, Part-3 (Conditions of Contract) of Bid document.

13. **TESTING, INSPECTION AND QUALITY ASSURANCE:**

The Contractor shall submit a suitable Quality Assurance Programme (QAP) to the Engineer-In-Charge for his approval and approved QAP shall form an integral part of the Contract Agreement. **17. SIGNING OF CONTRACT AGREEMENT:**


