Dear Sir(s),

With reference to above, the North Eastern Electric Power Corporation Limited (NEEPCO) intends to award you the work of "**Construction of Plunge Pool and Extension of Apron at d/s of Bichom Dam under Kameng Hydro Power Station (erstwhile Kameng H.E. Plant), Arunachal Pradesh**" as per scope, terms and conditions of the Bid document, Corrigenda and Pre-Bid Clarifications issued thereto and Minutes of meetings held with you on 30-03-2022 and 20-04-2022 for a Contract Price of Rs. 27,89,34,419.61, which is rounded off to Rs. 27,89,34,420.00 (Rupees twenty seven crore, eighty nine lakh, thirty four thousand, four hundred twenty only). The following may be noted.

- With reference to the Minutes of Price Bid Negotiation Meeting held on 30-03-2022 (Ref iv above), the contract Price is arrived at by application of discount @ 1% on the rates of each BOQ items quoted in Price Bid.
- The Contract price is inclusive of all applicable taxes, duties, levies, cess etc in terms of Bid conditions.

- (iii) GST @18% is considered applicable, as on reference/ base date (25-11-2021, i.e. 28 days prior to the latest date for submission of bids). With reference to Minutes of Meeting held on 20-04-2022 (Ref i above), Sri Vijetha Engineers & Infra Structure Pvt. Ltd. shall approach the GST authority of appropriate jurisdiction seeking advance ruling on applicable rate of GST as on reference date (25-11-2021). Based on the advance ruling to be obtained from the GST authority, adjustment on the GST rate, if admissible shall be made in terms of Clause 73.2, Part-4 (Conditions of Contract) of Bid document.
- (iv) The time of completion for the entire scope of work is 26 (Twenty Six) months from the date of issue of Letter of Intent (LOI).
- (v) The rates quoted against BOQ Items No. 1.11, 1.21, 1.41, 9 & 13 are considered as Abnormally High Rates (AHR) in terms of Clause No. 23.1(iii), Part-3 of the Bid document.

In terms of Minutes of Price Negotiation Meeting held on 30-03-2022, Field Hostel accommodation of 9 (nine) rooms and 1 (one) family quarter in Bichom shall be provided to you for accommodation of your field staff during execution of the work under following terms & conditions:

- (i) Electricity charges for these accommodations shall be recovered based on actual consumption.
- (ii) The accommodation so provided shall not be misused and shall be maintained with due care during the period of occupation and handed over to the Corporation on completion of the work in good condition to the satisfaction of the Engineer-in-Charge.

You are requested to submit the following to the Engineer-In-Charge, within 15 (fifteen) days from the date of issue of LOI, for his approval. The same shall form an integral part of the Contract Agreement.

- (i) Work Programme indicating the sequence of various activities and the order of procedure proposes to be adopted to carry out and complete the work in all respect within the stipulated time of completion.
- (ii) Mobilisation Schedule of manpower.
- (iii) Mobilisation schedule of plants & equipment.
- (iv) Mobilisation schedule of materials required for the job indicating the source.
- (v) A Quality Assurance Programme (QAP).

In terms of Clause 27, Part-3 & Clause 3(i) of Part-4 of Bid Document, an Initial Security Deposit (ISD) equivalent to 1% (one percent) of the Contract Sum i.e. for an amount of Rs. 27,89,344.00 (Rupees twenty seven lakh eighty nine thousand three hundred forty four only) shall be submitted to this Office in the form of Bank Guarantee as per the prescribed format provided in **Annexure-I** of Part-3 of Bid Document, within 21(twenty one) days from the date of issue of the LOI.




