3. Commencement of Service:

The date of commencement of the service shall be with effect from 01-01-2025.

4. Completion Time:

The time of completion/ period of engagement shall be 24(Twenty- four) months to be reckoned from the date of engagement of security personnel i.e. with effect from 01-01-2025

5. Taxes, Duties, Levies etc.:

The rates as indicated against various items of works in the Bill of Quantities are inclusive of all applicable Taxes that may be leviable by Government or any other agency.

Any variation (increase/decrease) in the above-mentioned taxes, duties, etc. including introduction of new taxes, duties, etc. that may arise during the currency of the Contract shall be adjusted in the Contract Price on production of documentary evidence.

6. Terms of Payment:

The payment to the Contractor for the performance of the works under the Contract shall be governed by the provisions of Clause 17, Section-V, Special Conditions of Contract and other relevant provisions in the Bid Document.

Wages and allowances as admissible under the relevant laws have to be paid to the engaged personnel by the 7th day of each month. The contractor must ensure that the wages to the security person are paid in due time failing which the contract will automatically stand cancelled.

7. Price Adjustment/ Variation:

Price adjustment in respect of the work shall be governed by the provisions of Clause 18, Section-V, Special Conditions of Contract and other relevant provisions in the Bid Document.

The Contractor shall pay wages to the personnel employed by him at the rate, which shall not be less than the minimum wages of Government's notifications under relevant Acts and Rules from time to time. The above minimum wages (i.e. basic + VDA) shall be as per DGR Minimum Wage Notification during the period of consideration.

8. Paying Authority:

Payment shall be released by the Head of Finance, F&A, AGBPS, NEEPCO Ltd., who shall release the payment based on certification by the Officer-in-Charge for Security of AGBPS, Bokuloni, Dibrugarh.

9. Contract Performance Guarantee

Performance Security shall be 10% of the First Month's wage bill of the Security agency which shall be deducted in the first month.

The Contract Performance Guarantee shall be released to the Contractor without interest, after he duly performs and completes the contract in all respects but not later than 60 (sixty) days of completion of all such obligations under the contract. No interest shall be payable to the Contractor by the Corporation against the Contract Performance Guarantee.

10. Signing of Agreement:

- i) The Contract Agreement shall be signed by the Corporation and the Contractor following the issue of Detailed Work Order along with acceptance thereof. The Contractor shall submit 3(three) Nos. of Non-Judicial Stamp Papers of Rs.100.00 (Rupees one hundred only) each to be purchased by the Contractor in the State of Meghalaya for signing the Contract Agreement.
- ii) Until a formal Contract Agreement is executed, DWO read in conjunction with Bid Document of NIB No.458 Dated 07-11-2024 shall constitute a binding Contract between the Contractor and the Corporation.

You are requested to kindly acknowledge the receipt of this Detailed Work Order and convey your unconditional acceptance of the same within 5(five) days from the date of issue of this DWO to enable signing of the Contract Agreement as early as possible.
