The work shall be executed as per Terms of Reference, Conditions of Contract and all other Terms and Conditions stipulated in the Bid Document.

- 2. <u>Time of Completion</u>: Time of completion is 04 (four) months from the date of issue of Letter of Intent or till recommendation of certification by concerned certifying body. Further extension of time beyond 04 (four) months if required due to delay in recommendation of certification by concerned certifying body for valid reason, shall be granted on recommendation of HoP/HoD of the respective locations/ Engineer-In-charge, without any extra financial involvement to the Corporation. The scope of Consultant ceases with the recommendation for certification by certifying body.
- 3. <u>Contract Price:</u> The Contract Price is Rs. 9,02,501.00 (Rupees Nine Lakh Two Thousand Five Hundred and One) only including GST.
- 4. The Consultant shall submit a Work Plan indicating the sequence of various activities to the Engineer-in-Charge, within 7(seven) days from the date of issue of the LOI, for his approval, as per Clause 5.5, Part-2 of Bid Document:
- 5. Contract Performance Guarantee (CPG):

The Consultant, within 15(fifteen) days from the date of issue of the LOI, for due performance of the Contract, shall submit to the undersigned a CPG in the form of Bank Guarantee from a Nationalized Bank/Scheduled Bank located in the country of the Corporation or a Non-Nationalized Bank to be confirmed by any of the Nationalized Bank in India for an amount equal to 10% (Ten percent) of the Contract Price as per prescribed format as provided in **Annexure-4** of Part-2 of Bid Document, in terms of Clause 5.4, Part-2 of Bid Document.

Alternatively, the Consultant shall deposit the CPG amount through SB-COLLECT of State Bank of India by following the steps given in Clause 5.4(i), Part-2 of Bid Document.
