INSTRUCTIONS:

- 1. You will use OMR (Optical Mark Reader) answer sheet provided to you during the test to register your response to the multiple choice objective type 100 questions to be completed within 2(two) hours duration starting at 10:00 AM. Each correct response carry 1(one) mark. There is no negative marking for wrong response.
- 2. You should reach the Test Venue positively by the Reporting Time & produce this Call Letter cum Admit Card failing which you will not be permitted to appear in the test.
- 3. Only the candidate shall be allowed to enter the Test Venue. No other person(s) accompanying the candidate shall be allowed to enter the test venue.
- 4. Use only blue / black ball point pen on the OMR Answer Sheet. Use of Pencil, marker or correcting white fluid is strictly prohibited. Please read the instructions carefully for filling up the OMR Answer Sheet provided to you in the Examination Hall.
- 5. You are requested to bring your own Ball Point Pen (Blue or Black).
- 6. You are required to produce the following documents for verification of Identity(ID) at the time of reporting:
 - (a) Photo Identity proof e.g. PAN Card / Voter ID / Driving License / Aadhaar Card / Passport / Students ID Card, etc. in original, and one photocopy (self-attested).
 - (b) Proof of Date of Birth i.e. School Certificate / Birth Certificate and one photocopy (self-attested).
- 7. The date, venue and time fixed for Written Test cannot be changed under any circumstances and no application/representation will be entertained in this regard except due to Bandh /picketing etc. in the locality.
- 8. Merely appearing in the Written Test will not confer upon you any right to claim against the post.
