It may please be informed that Go Digit General Insurance Ltd. have participated against our tender for "Renewal of Industrial All Risk (IAR) Insurance Policy for the Assets of Doyang Hydro Power Station (75 MW), DHPS, Doyang, Nagaland, for a period of 1(one) year w.e.f. 00:00:00 Hours of 01.04.2025" invited vide Bid No. GEM/2025/B/5816535 Dated 15.01.2025. The Techno-Commercial Bids were opened on 12.02.2025 and opening of Price bids was scheduled on 11.03.2025. Subsequently, Go Digit General Insurance Ltd. have communicated vide email Dtd. 10.03.2025 stating that they have deviations from bid stipulations as a part of their bid submitted.

Since the communication made vide email Dtd. 10.03.2025 being a modification of submitted bid after bid opening and during the period of bid validity, NEEPCO requested Go Digit General Insurance Ltd. vide email Dtd. 11.03.2025 for withdrawal of the deviations. However, Go Digit General Insurance Ltd. vide email Dtd. 11.03.2025 has expressed their inability to withdraw the deviations.

In the backdrop of above and in terms of bid provisions stipulated at Clause 3.0(v) Section-III: Instruction to Bidders of the Bid document/ATC (GeM Bid No. GEM/2025/B/5816535 Dated 15.01.2025) and as per the undertaking submitted by Go Digit General Insurance Ltd. in the bid against Form F-8: Bid Security Declaration, the bidder i.e. Go Digit General Insurance Ltd., is hereby suspended for participation in future tenders of NEEPCO Ltd. for a period of 2(two) years from the date of issue of this Notice.
