Following Corrigendum to the Bid Document is hereby issued.

Part 1: Short & Detail Notice Inviting Bids.

7.1 General Requirement for The Bidder:

- A bidder who may be an individual or Partnership firm or Limited liability Partnership or Private/ Public Ltd. company shall be a registered entity in India. The bidder shall furnish copies of documents in support of its registration in India, Company profile, copy of Memorandum of Association (MOA) of Company/Organization etc along with the Techno-commercial bids.
- The Bidder must be a Project Affected Families (PAFs)/ local residing near to the Project, Tato-II H.E Project (700 MW).

Each bidder should submit the document for above 7.1 (ii):

- Permanent Residential Certificate (PRC)/Documents regarding proof of locals issued by the respective State Govt. Authority/District Authority/Circle officer/Tehsildar, which defines/ determines the bidder as Permanent Local resident of the notified areas. It is clarified that any Govt. document showing mere proof of residence shall not be accepted for registration as Local Contractor.

Following districts of Arunachal Pradesh are hereby considered as Notified area i.e. geographical limit for the "Reservation of works to PAFs and Locals residing near to the Project/ Power Stations": -

- (i) a family whose land or other immovable property has been acquired;
- (ii) a family which does not own any land but a member or members of such family may be agricultural labourers, tenants including any form of tenancy or holding of usufruct right, share-croppers or artisans or who may be working in the affected area for three years prior to the acquisition of the land, whose primary source of livelihood stand affected by the acquisition of land;
- (iii) the Schedule Tribes and other traditional forest dwellers who have lost any of their forest rights recognized under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 due to acquisition of land;
- (iv) family whose primary source of livelihood for three years prior to the acquisition of the land is dependent on forests or water bodies and includes gatherers of forest produce, hunters, fisher folk and boatmen and such livelihood is affected due to acquisition of land;
- (v) a member of the family who has been assigned land by the State Government or the Central Government under any of its schemes and such land is under acquisition;
- (vi) a family residing on any land in the urban areas for preceding three years or more prior to the acquisition of the land or whose primary source of livelihood for three years prior to the acquisition of the land is affected by the acquisition of such land.

(Note: The certificate, as desired at Sl. No. (i) to (vi) above- should mention name of the village, Circle and name of District of the bidder besides explicitly mentioning whether the bidder is a Project Affected Family (PAF) or a beneficiary under Rights and Privileges, whichever is applicable. The certificate should clearly mention that the same is being issued only for participating in the Notice inviting Tender invited by NEEPCO.)

In support of the criteria under sl. No. 7.1 (ii), II above, "the bidder shall submit a certificate issued to him or his dependent/legal heirs/constituents of entity by the respective State Govt. Authority / District Authority / Circle Officer / Tehsildar / any other Authority legally entitled to or entrusted by the State Government".

- iii) As per Clause No. 3(b) of 'Public Procurement (Preference to Make in India), Order 2017, issued vide Order No. P-45021/2/2017-PP/BE-II dated 16-09-2020 of Department for Promotion of Industry and Internal Trade (Public Procurement Section), Ministry of Commerce and Industry, Government of India, read in conjunction with Order No. A-1/ 2021-FSC-Part(5) Dated 16-11-2021 of Ministry of Power, Government of India, only 'Class-I local supplier' & 'Class-II local supplier' shall be eligible to participate in this bid. For definition of 'Class-I local supplier' & 'Class-II local supplier', bidders may refer Clause No. 4(ix), Part-II, Vol-1 of Bid document.

- iv) For domestic bidders having relation with an entity incorporated, established or registered in a country which shares a land border with India, as defined in Order (Public Procurement No. 1) dated 23rd July, 2020 and Order (Public Procurement No. 2) Dated 23rd July, 2020, both issued by Public Procurement Division, Department of Expenditure, Ministry of Finance, Government of India, the provisions of these orders shall apply.
- v) Provident Fund Registration number. Bidder should submit a copy of the EPF registration along with the Techno-commercial Bid, otherwise 25.69% (comprising of 12% labour wage + 12% employer's contribution + 1.69% administrative charge) on the labour wage will be deducted from the bill of the successful bidder and the same will be deposited in NEEPCO, EPF Trust.
- vi) The bidders shall submit the copies of Registration Certificate for GST and PAN (Permanent Account Number) for Income Tax along with the Techno-commercial Bid.

All others terms and conditions of the Bid Document shall remain unchanged.
