Name of Work: Package-III: Civil Works of Power Intake, Head Race Tunnel, Surge Shaft, Valve chamber, Pressure Shafts & Penstock, Underground Powerhouse Complex (comprising of Powerhouse Cavern, Transformer - GIS Cavern, Collection Chamber, Main Access Tunnel (MAT), Cable Access Tunnel (CAT)) Unit Tail Race Tunnels, Main Tail Race Tunnel, Pothead Yard and various Construction Adits pertaining to Tato-II Hydro Electric Project (700 MW), Arunachal Pradesh.

Following corrigenda to the bid document are hereby issued:

Part- 1: Short & Detail NIB

1. The provisions stipulated in Clause 6.2.2 (i) (b) of Part-1: Short & Detail NIB of Bid Document stand modified as below:

Underground shaft - Completion of excavation, support of at least one shaft of minimum 3 m finished diameter and minimum 75 m height in completed/ongoing project.

The provisions stipulated in Clause No. 6.2.2 (ii) of Part-1: Short & Detail NIB of Bid Document stand modified as below:

Power House Civil Works:

Civil works including construction of cavern and machine foundation in an underground power house in Hydro Electric Project/ Pump storage Project completed/substantially completed.

Construction of any cavern in hydropower/ pump storage/ infrastructure project completed/substantially completed AND construction of powerhouse in hydropower /pump storage project completed/substantially completed.

Minimum size of the cavern as required under sl. (i) & (ii) is 12m wide and 25m high.

Part- 3: Instruction to Bidders (ITB)

The provisions stipulated under 1st Para of Clause No. 23.1 (iii) of Part-3: ITB of the Bid Document may be read as below:

If the rates/ prices quoted by the successful bidder for certain items of the Bill of Quantities are found to be abnormally high or low in relation to the estimated cost, then the Employer may request the bidders to produce detailed rate/ price

analysis for any or all items of the Bill of Quantities, to determine the internal consistency of these rates/prices with the Construction Method and construction Schedule proposed. After evaluation of the rates/prices analysis, and explanation given by the bidder, the Employer reserves the right to declare rates of such items as Abnormally High Rate (AHR) / Abnormally Low Rate (ALR). In the event a bid, which results in the lowest Evaluated Bid Price is front loaded in relation to the Employer's estimate of the items of work to be performed at early stage under the Contract, the Employer may require that the amount of the performance security be increased at the expense of the successful bidder to protect Employer against financial loss in the event of default by the Contractor under the Contract, if award is placed on recommended bidder.

- 4. The provisions stipulated at Notes 1 of Annexure- IA: Performance Security Bank Guarantee (To be submitted by the Partners of Joint Venture) of Part-3: ITB of the Bid Document may be read as below:
 - (*) This sum shall be ... % (......percent) in proportion of the participation share of the partner in the Joint-Venture totaling to percent of the Accepted Contract Amount denominated in the types and proportions of currencies as guided by Clause 4.2 of PCC.
 - (@) This date shall be Sixty (60) days after the end of the Defects Notification Period. (+) This date shall be guided by Clause 4.2 of GCC/PCC.

All others terms and conditions of the Bid Document and subsequent modifications issued through corrigenda shall remain unchanged.
