Name of Work: Package-III: Civil Works of Power Intake, Head Race Tunnel, Surge Shaft, Valve chamber, Pressure Shafts & Penstock, Underground Powerhouse Complex (comprising of Powerhouse Cavern, Transformer - GIS Cavern, Collection Chamber, Main Access Tunnel (MAT), Cable Access Tunnel (CAT)) Unit Tail Race Tunnels, Main Tail Race Tunnel, Pothead Yard and various Construction Adits pertaining to Tato-II Hydro Electric Project (700 MW), Arunachal Pradesh.

Following corrigenda to the bid document are hereby issued:

Part- 1: Short & Detail NIB

1. The provisions stipulated in Note 1 under Clause No. 6.2.1 of Part-1: Short & Detail NIB of Bid Document stand modified as below:

"Similar works" are defined as execution of Civil works involving Highway Tunnel Projects/ Railway Tunnel Projects/Water Resources Projects/Hydro Power Projects/ Metro Projects/other civil infrastructure projects.

2. The provisions stipulated in Clause 6.2.2 (i) (a) of Part-1: Short & Detail NIB of Bid Document stand modified as below:

Tunnel of not less than 5.20 m diameter (Finished)- Excavation and Concrete Lining of at least 1500 m in a single Project with continuous boring length of more than 750 m completed/substantially completed.

3. The provisions stipulated in Clause 6.2.2 (i) (b) of Part-1: Short & Detail NIB of Bid Document stand modified as below:

Underground shaft – Excavation, support of at least one shaft of minimum 3.0 m finished diameter and minimum 100 m height completed/substantially completed.

4. The provisions stipulated in Clause No. 6.2.2 (ii) of Part-1: Short & Detail NIB of Bid Document stand modified as below:

Power House Civil Works:

- i) Civil works of an Underground/surface/sub-surface Power house in Hydro Electric Project/ Pump storage Project completed/substantially completed.

- ii) Civil works of at least one cavern of minimum size 12 m wide and 25 m height in a Hydro Power/Pump storage /civil infrastructure project completed/substantially completed.
5. The provisions stipulated in Clause No. 6.3 (i) of Part-1: Short & Detail NIB of Bid Document stand modified as below:

Average Annual Turnover of the bidder from Civil Construction Works in the immediately preceding 2 (two) consecutive financial years shall be at least **INR 227.00 Cr.** (Rupees Two Hundred Twenty Seven Crore) only or Equivalent US \$ / Euro etc.

Annual Turnover should be from civil construction works as certified by Certified Public Accountant (CPA)/ practicing Chartered Accountant with UDIN. Other income shall not be considered for arriving at the minimum average annual turnover.

For conversion of US \$ / Euro etc. to INR, the exchange rate at the end of the respective accounting year shall be considered.

All others terms and conditions of the Bid Document shall remain unchanged.
