The Contractor has to take up repair & maintenance of roof treatment works within one month from raising of any complaint by NEEPCO related to water leakage. The special security deposit shall be released after completion of 05 years from the completion date of work, subject to satisfactory performance of those items and attendance to roof leakage related complaint during the 5 years" may kindly be read as "The laying of APP sheet and fiber glass clothing is to be carried out by an Authorized Agency. 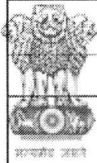
