Part-1: Short & Detail NIB

- 1. The provisions stipulated in 1st para, Clause 6.2.1 (General Experience) stand modified as under:
 - "Bidder shall have General Experience as Prime Contractor or Partner of Joint-Venture/ Consortium or Sub-contractor approved by the Project Developer, of executing the following works in ongoing/ completed project, during last 20 (twenty) years ending on last date of submission of Bids:"
- 2. The provisions stipulated in 1st para, Clause 6.2.2 (Specific Experience) stand modified as under:
 - "The Bidder as Prime Contractor or Partner of Joint-Venture/ Consortium or Sub-contractor approved by the Project Developer, shall have successfully executed the following works, during last 20 (twenty) years ending on last date of submission of Bids."

Meter and water head at bottom sill level in meter respectively) along with rope drum hoist in a Hydro Power/Water Resource Project".
