The following corrigendum to the Bid Document/ ATC is hereby issued:

# INSTRUCTION TO BIDDERS AND FORMS & DATA SHEETS

# 1. Clause 1.9.3 (i) of ITB shall be read as below:

The Bidder are also strongly advised to familiarise themselves about the prevailing standards and practices as prescribed by Central Electricity Authority (CEA), Central Water Commission (CWC), Geological Survey of India (GSI), Survey of India (SOI), Indian Meteorological Department (IMD), Bureau of Indian Standards (BIS), Ministry of Power, Ministry of Environment, Forest and Climate Change (MOEF & CC) and other agencies for the preparation of Design and Review Consultancy works. The Consultant shall be solely responsible for preparation of Design and Review Consultancy works which shall be approved by Competent Authority, and hence all standard norms and procedures shall have to be strictly followed.

# 2. Clause 3.3 (i) of ITB shall be read as below:

The Contract is for the Consultancy Services of Design and Review Consultancy works, as described in the Terms of Reference, based on the Price Schedule as submitted by the bidder. The bidder shall quote rates / prices for the Item of the Services as described in Price Schedule for the complete scope of service and the Rates/Prices shall be treated as firm. No price adjustment shall be payable against the Contract and no claim in this regard shall be entertained.

## 3. Clause 3.3 (v) (iv) of ITB shall be read as below:

Other miscellaneous components/items which are considered necessary for satisfactory completion of the Design and Review Consultancy works, in all respect.

# 4. Clause 3.3(vi) of ITB is included under Bid Price.

The bidders shall indicate the particulars of taxes, duties, levies, cess, etc., as applicable as on 28(twenty-eight) days prior to the latest date for submission of bids, considered/included in quoted rates separately in **Form-2: Price Break Up Format & Schedule of Payment** of Bid Document/ATC.



## **SPECIAL TERMS AND CONDITIONS**

### 1. Clause 21.1 of STC shall be read as below:

The Consultant's quoted prices are deemed to be inclusive of all applicable Indian & Non-Indian Taxes, Duties, Levies, Royalties, Income Tax, Professional Tax, etc. that may be leviable by Government or any other agency and lawfully assessed against the work during currency of the contract. All applicable Taxes, Duties, Levies etc. shall be paid directly to the authority concerned by the Consultant and the same shall be reimbursed/paid by the Corporation to the Consultant, at actual, on production of documentary evidence/ tax invoice. The Consultant shall be solely responsible for the compliance of all the formalities as required under all the Taxation Laws in force.

All other terms and conditions contained in the Bid Document/ATC shall remain unchanged.
