Following corrigenda to the Bid Document containing Additional Terms and Conditions are hereby issued:

#### Part- I: Instruction to Bidders and Tender Forms & Data Sheets

1. The provisions stipulated in Clause No. 1.5.2 (Technical Qualifying Requirement), is modified as below:

The bidder should have experience of either of the following:

- i) Preparation & submission of Detailed Project Report of at least 1 (one) Hydro Project having Installed capacity not less than 100 MW including obtaining approval/clearance from CEA/State Govt. for projects located in India or equivalent certification by Govt. agencies for projects located abroad within last 15 (fifteen) years prior to the last date of submission of the bids;

Or

- ii) Preparation & submission of Detailed Project Report at least up to submission of Pre-DPR Chapters to the client for obtaining approval/clearance of appropriate authority of minimum 1 (one) Pump Storage Project of capacity atleast 100 MW within last 15 (fifteen) years prior to the last date of submission of the bids.

#### Notes:

1. The DPR (for projects located in India) or Feasibility Report (FR) (for projects located abroad) of the project should be prepared & submitted by the bidder itself. Experience of the Parent Company/Subsidiaries/Holding Company shall not be considered for evaluation. The supporting documents submitted against proof of experience must be issued in the name of the bidder. Supporting documents in the form of copies of Work Order / Contract with detailed scope of works/service, value of the work, date of successful completion/submission, certificate of satisfactory completion/up-to-date completion from client/employer/owner, name, address, email ID & contact number of the client/employer /owner etc. shall be furnished along with the Techno-Commercial Bids.
  2. For Hydro Projects, completion of DPR/FR means approval/issuance of clearance by CEA/State Govt. for projects located in India or equivalent certification by Govt. agencies for projects located abroad.
  3. For Pump Storage Project, eligible experience means submission of Pre-DPR Chapters to the client for obtaining approval/clearance from the appropriate authority.
