NEEPCO reserves the right to ask for proof of actual payment to the personnel engaged by him, as and when desired. In the event the contractor fails to comply with various labour laws, NEEPCO reserves the right to recover all the statutory dues such as Employer's share of Provident Fund, Pension and other statutory dues and pay to the concerned Statutory Authorities. NEEPCO will not be liable to pay any compensation to / or on behalf of the contractor to the personnel engaged by him.</i></p>
