**CORRIGENDUM NO. 4 DATED 02/07/2021**

**TO**

**NIB NO. 390 DATED 12/05/2021**

**NAME OF WORK:** "Day to Day Operation & Maintenance including Annual Planned Maintenance service of 4 x 150 MW Kimi Power House, 400KV and 132 KV Switchyards, Generator Transformers, etc. along with all other Ancillary /Auxiliary Equipment/Components & Operation of Kameng Hydro Electric Plant"

**Corrigendum to the NIB is hereby issued as below:**

- 1. Clause No. 2.2.1(Minimum Average Annual Turnover(MAAT)), Section I (NIB), stands amended as below:**

"The average annual turnover of the bidder in the best 3(Three) financial years out of the last 5(five) financial years should not be less than Rs. 16.32 Crores (Rupees Sixteen Crores and Thirty Two) Lakhs."

- 2. Clause No. 2.2.3 (Liquid Assets), Section I (NIB), stands amended as below:**

"The bidder should have liquid assets or / and evidence to availability of unutilized credit facilities of not less than Rs. 2.26 Crores (Rupees Two Crores Twenty Six Lakhs). The certificate of the Banker regarding the availability of unutilized credit facility should not be dated earlier than 30 (thirty) days prior to the date of opening the bid. Liquid Asset = Current Asset – (Inventory + Pre-Paid expenses)"

- 3. Clause No. 2.2.4 (Bid Capacity), Section I (NIB): The 1<sup>st</sup> para of this clause stands amended to the following extent:**

"The available Bid Capacity of the Bidder at the time of submission of Bid, calculated as under should not be less than INR 32.65 Crores (Rupees Thirty Two Crores Sixty Five Lakhs)."

- 4. Clause No. 8 (Contract Period), Section II (Instruction to Bidders) stands amended as below:**

"The Contract shall remain valid for a period of 3(Three) years from the date of mobilization at site by the Contractor, subject to satisfactory performance of the contractor which shall be reviewed annually. In case of sub optimal performance with regard to the performance of the machine, the owner will have the right to terminate the contract by giving three month notice. The Contractor shall mobilize within 30 days from the date of issuance of Letter of Intent (LOI)."

- 5. Price Schedule – I, Section VII (Price Schedules) shall be read as below:**

"1(One) year, as mentioned under various columns and under "Note", shall be read as 3(Three) years".

Further, Column Number 5 of the Price Schedule shall be read as: "Basic Rate for 3(Three) years". The bidders will accordingly quote the price for 3(Three) years.
