The above NIB in respect of "supply installation & commissioning of Various Calibration instruments as per Specified make and Model for Agartala Gas Turbine Combine Cycle Power Plant, NEEPCO Ltd. Agartala Tripura(West)" is amended to the following extent:

1. The clause number 3 under the head Qualification criteria of the NIB shall now read as

The bidders shall have supplied similar type of instruments in any Govt. of India organization/State Govt. organisation /PSU during last 7years. Documentary evidence to that effect shall be submitted in either of the following manner.

- a) Three (3) supplies of similar items each of value not less than Rs 2,14,644/-.
 OR
- Two (2) supplies of similar item each of value not less than Rs 2,68,306/-.
 OR
- C) One supply of similar items value not less than Rs 4,29,289/-.

The similar work means supply and installation and commissioning of same or similar type of various calibration instruments.

Instead of

The bidders shall have supplied similar type of instruments in any Govt. of India organization/State Govt. organisation /PSU during last 7years. Documentary evidence to that effect shall be submitted.

a) Three supplies of similar items of 40% of offered rate

OR

b) Two supply of similar items not less than 50% of offered price.

OR

- c) One supply of similar items not less than 80% of the offered price
- 2. The clause number (5) the head Qualification criteria of the NIB shall now read as

The average Annual Turnover shall not be less than Rs 6,00,000(Rupees six lacs) only during the financial year 2013-14.2014-15.2015-16 and certificate in respect of this shall be submitted.

Instead of

The average Annual Turnover certificate equivalent of 30 % of offered amount during the last three years should be submitted.

All other terms & conditions of NIB will remain unchanged.
