ANNEXURE-I

- ix) The Purchaser reserves the right to award the contract as per Purchaser's discretion irrespective of the live Auction Rank.
- x) After completion of reverse auction, the lowest bidder has to fax the duly signed filled in prescribed format confirming the price quoted along with price break up as per Price Schedules of NIB within 24 hrs of auction without fail.
- xi) The L1 bidder shall furnish the price break up after reverse auction which shall be proportionately distributed among each line item in line with the original price quoted.
- xii) After completion of reverse auction, the purchase will evaluate the L1 bid received after reverse auction along with the original price bids already opened to assess the lowest evaluated bid.
- xiii) If no bid is received during reverse auction within the specified time duration of the online reverse auction, the original quoted price of the bidders shall be processed to evaluate the lowest bid.
- xiv) If the L1 bidder as per the original quoted prices does not participate in the e-reverse auction and the L1 bid received during reverse auction happens to be the same as the L1 price evaluated as per original quoted prices of the bidders, then the L1 bid received during reverse auction shall prevail and shall be considered for evaluation and award.
- xv) The prices quoted in the e-reverse auction shall be the total lump sum prices as per the scope of work in the tender inclusive of all taxes & duties, levies, deviations considering the loading factor furnished by the Purchaser on his quoted prices.
