- 1. The 1st para of Cl. 1.3.5: Intake Trash Rack of Part-2: Information for Bidders of Bid Document stands modified as below:
 - Three (3) sets of inclined trash racks, for the bay of bay opening size of 5.0m wide x 20.5 m high complete in all respect. Each set of trash racks consisting of eight (8) panels each of size 5.0 m wide x 2.55 m height.

Three (3) number hinged type adit gate suitable for opening size of 2.5 m wide x 2.5 m high comprising of skin plate, stiffeners, girders, sealing and bearing members, connecting hinge members and suitable piping and valves (minimum 250 mm \varnothing) for dewatering purpose and pressure gauge for measuring HRT water pressure.

 - 3 (Three) set of trash-rack each consisting of 6 (Six) panels suitable for bay opening of size 3.5 m (w) x 19.5 m (inclined height) handling and fixing to the built-in steel support frames, shall be designed, supplied, installed, tested and commissioned at the Inlet of Power Intake as shown in specification drawings.
- 7. The 1st para Cl. 10.1: Gate Assembly of Part 5B: Particular Technical Specifications for Gate and Hoist stands of Bid Document is modified as below:
 - Three (3) set of hinged type gate suitable for clear vent opening size of 2500 mm x 2500 mm (w x h) is proposed at Adits of HRT to facilitate access through adit for inspection, repair & maintenance of HRT in future. During operation of the plant the gate shall be safely and tightly closed to withstand the static water pressure acting on the tunnel side.

The payment shall be released in phased manner against the progress achieved in the milestones stated below:

1. Milestone- A: Design and Drawings

Payment at 5 % (Five percent) of BoQ amount shall be paid to the Contractor against approval of the design and drawings on certification by the Engineer-In-Charge.

2. Milestone- B: Fabrication and Supply of Equipment

Payment at 60% (Sixty percent) of BoQ amount shall be paid to the Contractor against supply of complete equipment at project site on certification by the Engineer-In-Charge.

3. Milestone- C: Erection of Equipment

Payment at 25% (Twenty five percent) of BoQ amount shall be paid to the Contractor against erection of complete equipment on certification by the Engineer-In-Charge.

4. Milestone- D: Trial Run and commission

Payment at 10% (Ten percent) of BoQ amount shall be paid to the Contractor against successful commissioning and trial run of the equipment on the basis of handing over certificates issue to the Contractor by the Engineer-In-Charge.

- 10. The provisions under SI. No. (B), Cl. 1.4: Schedule of Payment of Part 8: Bill of Quantities and Schedule of Payment of Bid Document are modified as below:
 - 1. Milestone- A: Design and Drawings

Payment at 5 % (Five percent) of BoQ amount shall be paid to the Contractor against approval of the design and drawings on certification by the Engineer-In-Charge.

2. Milestone- B: Supply of Steel plates

Payment at 45% (Forty Five percent) of BoQ amount shall be paid to the Contractor against procurement of materials required for completion of the works progressively on submission of proforma invoice and verification of Mill test certificate etc. by the Owner. However, payment against this milestone shall be restricted to the quantity as per approved fabrication drawings.

3. Milestone- B: Fabrication

Payment at 25 % (Twenty Five percent) of BoQ amount shall be paid to the Contractor after fabrication of the liner ferrules as per approved fabrication drawings progressively on the basis of acceptance certificate issued by the Owner.

4. Milestone- C: Erection

Payment at 20 % (Twenty percent) of the BoQ amount shall be paid to the Contractor after erection of the equipments as per progress achieved in the erection works and acceptance of the same by the Owner. However, payment against this milestone shall be restricted to the quantity as per approved fabrication drawings.

5. Milestone- D: Commissioning and trial run of the Penstock & Steel In-Liner.
