“Design, Engineering, Manufacture, Shop Testing, Inspection at manufacturer’s works before dispatch, Packing & Forwarding, Transportation and Delivery at Site including Transit Insurance, Loading & Unloading, and Supervision of complete Erection, Testing and Commissioning of 5(Five) Nos. ( 4 + 1 Spare) 63 MVA, ONAF/OFAF Cooled, 11KV/220 KV, Three phase Generator Step Up Transformers complete with all accessories/ fittings and spare part as specified in the Bid Document for Kopili H.E. Power Plant (4x50MW), Assam, India”

**Corrigendum to the bid document is hereby issued as below:**


1. The following shall be added to Clause No. 28(I), Section II(Instruction to Bidders) of Detailed Bid Document:

“c). As per Office Order No.25-11/6/2018-PG dated 02/07/2020 of Ministry of Power, Government of India (Copy enclosed), the following shall be complied:

- i.. All equipment, components, and parts to be imported against the package shall be tested in India to check for any kind of embedded malware/trojans/cyber threat and for adherence to Indian Standards.
- ii. All such testings shall be done in certified laboratories that will be designated by the Ministry of Power (MoP).
- iii. Any import of Equipment/Components/Parts from "prior reference" countries as specified or by persons owned by, controlled by, or subject to the jurisdiction or the directions of these "prior reference" countries will require prior permission of the Government of India.
- iv. Where the Equipment/Components/Parts are imported from "prior reference" countries, with special permission, the protocol for testing in certified and designated laboratories shall be approved by the Ministry of Power (MoP).
- v. The above shall apply to any item imported for end use or to be used as a component, or as a part in manufacturing, assembling of any equipment or to be used in the Package.
- vi. Regarding definition of ‘Prior Reference Countries’ and exclusions applicable on the above, the bidders may refer Office Order No. 25-4/1/2019-PG-Part (1) dated 11/08/2020 of Ministry Of Power, Government Of India(copy enclosed)”

Further to the above, clarifications to pre – bid queries, in the form of Pre-Bid Clarification No. 1, is attached herewith.

All other terms and conditions of the Detailed Bid Document and NIB shall remain unchanged.
