Detailed Notice Inviting Bid (Domestic Competitive Bidding)

The North Eastern Electric Power Corporation Limited (NEEPCO), a Public Sector Enterprise under the Ministry of Power, Government of India invites Single-Stage Two Envelope Bids through online bidding system from eligible bidders for "Supply & Installation of Polycom DMA 7000" at NEEPCO Ltd Shillong.

1. Scope: Supply, delivery, installation & commissioning of Polycom DMA7000 and successful integration with the existing Polycom Video Conferencing (VC) equipment installed at Project Monitoring Center, NEEPCO Corporate Office, Shillong, Meghalaya.

The bidder are advice to inspect the present VC System in Project Monitoring Center, NEEPCO Corporate Office, Shillong where the DMA7000 needs to be installed and integrated at their cost in order to assess the nature and cost of work required to be done.

2. PERIOD OF CONTRACT: The entire scope of work shall be completed within 6(six) weeks from the date of issue of Letter of Intent (LOI).

3. QUALIFYING REQUIREMENTS:

3.1 Technical

- (i) The bidder shall be Original Equipment Manufacturer (OEM) i.e. Polycom or Authorized Service Provider of Polycom, who must have successfully executed at least 2 (two) similar orders in India during last 5 (five) years prior to the date of opening of the bid. The bidder should furnish copies of detailed orders and also performance certificates from the customers, which should indicate the dates of award of the work and also indicate that the work is executed to the satisfaction of the customer. Similar order in this case shall mean work order involving supply, delivery, installation & commissioning of Polycom make Video Conferencing equipment.
- (ii) In case of being Authorized Service Provider of Polycom, the bidder should furnish latest Authorization Certificate from Polycom addressed to NEEPCO mentioning the tender enquiry number and the product.
- (iii) The bidder should not have been blacklisted by any Government/Government agency in India. Self-declaration to that effect should be submitted along with techno-commercial bid.

3.2 Financial

- i. Minimum Average Annual Turnover in the best 3(three) financial years out of the last 5(five) financial years, ending 31st March of the previous financial year, should not be less than Rs. 27,04,000.00 (Rupees Twenty Seven Lakh Four Thousand)
- ii. Net Worth:

The Net Worth of the bidder as on last day of the preceding financial year shall not be less than 50% of the Paid up Share Capital. The Net Worth shall be calculated based on Subscribed and

Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account & detailed Schedule and other financial statements for the preceding 5(five) financial years, ending 31st March of the previous Financial Year, along with Letter of adequacy and commitment from their Bankers/Financial Institutions of International repute should be furnished along with their bids for evaluating the above financial criteria. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable.

iii. Liquid Assets:

The bidder should have liquid assets or / and evidence to availability of unutilized credit facilities of not less than Rs. 24.14 Lakh (Rupees Twenty Four Lakh point One Four only). The Certificate of Banker regarding the availability of unutilized credit facilities shall not be dated earlier than 30 (thirty) days prior to the date of opening of bids.

iv. Bid Capacity:

The available Bid Capacity of the Bidder at the time of submission of Bid, calculated as under should not be less than Rs. 13.52 Lakh (Rupees Thirteen Lakh point Five Two) only

Bid Capacity = $A \times N \times 2 - B$, where

A = maximum value of works executed in any one year during last 7 (seven) years (at current price level).

N =Completion time of the proposed work in years.

B = Value at current price level of existing commitments and on going works to be completed during next N years.

Bid capacity shall be assessed at the time of submission of Techno-Commercial Bid, for which the bidder shall have to submit documentary evidence in support of "A" & "B" above along with their Bid without fail

- **4.** Complete Audited Annual Reports along with Audited Balance Sheets & Profit and Loss account and other financial statements for the best 3(three) financial years in the last 5 (five) financial years certified by a Chartered Accountant indicating the Annual financial turnover and latest Banker's Certificate in support of solvency shall be furnished.

7. Condition for Micro & Small Enterprises (MSEs)

- 7.1 The bidders participating as Micro/Small Enterprises (MSE) shall submit an Undertaking in the prescribed format given in the Bid Document declaring the status of their firm under the provisions of Micro and Small Enterprises along with a copy of the document/ certificate issued by any of the Authority mentioned below:
 - District Industries Centers
 - Khadi and Village Industries Commission
 - Khadi and Village Industries Board
 - Coir Board
 - National Small Industries Corporation (NSIC)
 - Directorate of Handicrafts and Handloom
 - MSEs having Udyog Aadhar memorandum
 - Any other Body specified by Ministry of Micro, Small and Medium Enterprises.
- 7.2 The MSEs owned by Scheduled Caste (SC) & Scheduled Tribe (ST) entrepreneurs must submit the SC/ST certificate issued by District Authority in addition to certificate of registration with any one of the agencies mentioned above. The bidder shall furnish necessary documentary evidence to ascertain that the MSE is owned by SC/ST. MSE owned by SC/ST is defined as:
 - a) In case of proprietary MSE, proprietor(s) shall be SC /ST.
 - b) In case of partnership MSE, the SC/ST partners shall be holding at least 51% shares in the enterprise.
 - c) In case of Private Limited Companies, at least 51% share shall be held by SC/ST promoters.
- 7.3 The registration certificate submitted by MSEs issued from any one of the above agencies must be valid as on close date of the tender. The successful bidder should ensure that the same is valid till the end of the contract period.
- 7.4 The MSEs who have applied for registration or renewal of registration with any of the above agencies/bodies, but have not obtained the valid certificate as on close date of the tender, are not eligible for exemption/preference.
- 7.5 The MSEs registered with above mentioned agencies/bodies are exempted from payment of BID FEES and EARNEST MONEY DEPOSIT (EMD).


