Part-4: Conditions of Contract

1. Clause 52 : Payment on Account:

In clause 52 (i) the sentence starting with "All payments made during the Contracts shall be on account payments only" stands deleted.

The clause 52(vi) related to mode of payment is modified as given hereunder:

All payments due to the Contractor except Advance payment and payment for Fabrication, Erection and Commissioning & Trial run of Penstock & Steel In-liner will be affected through an irrevocable, operable, at sight Letter of Credit (LC). LC format and document to be presented under LC shall be mutually agreed between NEEPCO and successful bidder after award of Contract. Charges towards opening of LC shall be borne by the Contractor.

For advance payment and payment for Fabrication, Erection and Commissioning & Trial run of Penstock & Steel In-liner, payment due to the Contractor shall be disbursed under e- payment system.

The Engineer-in-Charge or his authorized representatives will verify and certify the Contractor's invoices indicating payment instructions (full bank details) for disbursement.

Part-5: Technical Specification

2. Clause No. 16.4.4 : Testing at Contractor's premises:

The following are added to the above clause :

The Contractor shall give Engineer-in-Charge or his authorized representative 15(fifteen) days' written notice of any material being ready for testing. The Engineer-in-Charge or his authorized representative, unless the inspection of the tests is in writing waived, shall attend such tests within 15(fifteen) days from the date on which the equipment is notified by the contractor as being ready for test/inspection, failing which, the Contractor may proceed with the tests which shall be deemed to have been made and forward the certified copies of test results in quadruplicate, for approval of the Engineer-in-Charge. However, waiver accorded by the Engineer-in-Charge will not absolve the Contractor towards the execution of the Contract in conformity with the contract agreement.

3. Clause 19: Commissioning and Trial Run:

The last para of the above clause stands modified as given below:

After its completion, the Penstock and steel liner works shall be observed for a period of 48 (Forty-Eight) hours to ensure its satisfactory performance and absence of any leakage and thereafter the work shall be treated as commissioned and the work will be taken over by the Engineer In Charge.

All other terms and conditions contained in the Bid Document shall remain unchanged.
