- 2. The heading "Terrorism Cover for Ranganadi Hydro Electric Plant" indicated at Clause 2.0(i)(B) under Section-IV, Scope of Insurance Coverage, shall be read as "Terrorism Cover for Kopili Hydro Electric Plant, Stage-II (25 MW)".
- 3. Clause 8.0 under Section-V: Conditions of Insurance Policy shall be read as below:

Insurance Policy including Endorsements thereto shall be issued in the name of **Kopili Hydro Electric Plant, Stage-II (25 MW), Umrongso, Assam**. Both soft & hard copy of the policy shall be issued to NEEPCO. Kopili Hydro Electric Plant, Stage-II (25 MW), being the Insured, the Project Authority of KHEP shall be responsible for post award operation of the Insurance Policy i.e., lodging the insurance claims, follow-up, review, monitoring and final settlement as per policy conditions. However, claim intimation shall be sent to Contracts & Procurement Deptt., NEEPCO Ltd., Shillong for monitoring purposes. Contracts & Procurement Deptt., Corporate Office, Shillong along with O&M and Commercial Wing shall coordinate with the Projects for settlement of the Insurance claim under material damage as well as BI (FLOP and MLOP).
