

Plant (3x135MW), Arunachal Pradesh, India.

Clause No. 2.1.2 of Detailed NIB is amended to the following extent:

Bid Stipulation	Amendment
Design, Engineering, Manufacture, Shop Testing, Packing & Forwarding, Transportation including Transit Insurance, Delivery, Erection, Testing and Commissioning of Outdoor Gas Insulated Substation of voltage class 400 kV or higher, within a period of 7(Seven) years ending last day of the month prior to month in which this NIB is floated, which must have been in successful operation for a period of 2(Two) consecutive years. Details, including yearwise value of contracts executed, clients, proof of satisfactory completion of work and operation of such installations have to be furnished.	Design, Engineering, Manufacture, Shop Testing, Packing& Forwarding, Transportation including Transit Insurance, Delivery, Erection, Testing and Commissioning of Indoor / Outdoor Gas Insulated Substation of voltage class 400 kV or higher, within a period of 7(Seven) years ending last day of the month prior to month in which this NIB is floated, which must have been in successful operation for a period of 2(Two) consecutive years. Details, including year-wise value of contracts executed, clients, proof of satisfactory completion of work and operation of such installations have to be furnished.

All other terms and conditions of the NIB shall remain unchanged.
