## CORRIGENDUM 2 cum 1<sup>st</sup> EXTENSION TO NOTICE INVITING QUOTATION

No. 40 /Sr. M(E/M)/ C&P/ AGTCCPP/ 2016-17 Dtd. 12.07.2016

( Issued under Memo No. NEEPCO/ AGTCCPP/ Sr.M(E/M)/ C&P/ CS-40/ 2016-17/ 143 - 149 Dtd. 12.07.16)

The above NIQ in respect of "Supply, transportation, transit insurance and delivery of 500Mtr (Or its nearest drum length) of 4-core 35 sqmm armoured Copper Cable as required for Agartala Gas Turbine Combine Cycle Power Plant, NEEPCO Ltd. Agartala Tripura(West)" is amended to the following extent:

- 1. The clause under the head Earnest Money of the NIQ shall now read as:
  - " An amount of ₹ 27500/= (Rupees Twenty Seven Thousand Five Hundred) only to be submitted along with the offer online.

The Vendor can make the payment of the EMD as explained in Clause No. (b) Step 3 under the Head 'BIDDING PROGRAM' of the NIQ under reference above.

Or

An amount of ₹ 27500/= (Rupees Twenty Seven Thousand Five Hundred) only can be submitted along with the offer in the form of Demand Draft Drawn in favour of 'North Eastern Electric Power Corporation Ltd. 'and payable at 'Agartala' from any Nationalized / Scheduled Bank, failing which their bid shall not be considered. Also, the EMD should reach the office of the undersigned on or before the date of opening of the tender.

If a bidder withdraws the tender while it is under consideration or, after placement of order, the bid security /EMD shall be forfeited along with other action as the Corporation deems fit. The EMD of all unsuccessful bidders shall be returned only after placement of order with the successful bidder. "
