NOTICE INVITING TENDER

The above NIT in respect of the work of " **Replacement of the filter media of the Water Treatment Plant at AGTCCPP Residential complex and Office complex** " is amended to the following extent :

1. The clause under the head **Earnest Money** of the NIT shall now read as :

" An amount of ₹ 10500/= ( **Rupees Ten Thousand Five Hundred** ) only to be submitted along with the offer.

The Vendor can make the payment of the EMD as explained above in (b) Step 3.

Or

An amount of ₹ 10500/= ( **Rupees Ten Thousand Five Hundred** ) only can be submitted along with the offer in the form of Demand Draft Drawn in favour of ' **North Eastern Electric Power Corporation Ltd.** ' and payable at ' **Agartala** ' from any Nationalized / Scheduled Bank, failing which their bid shall not be considered. Also, the EMD should reach the office of the undersigned on or before the date of opening of the tender.

If a bidder withdraws the tender while it is under consideration or, after placement of order, the bid security /EMD shall be forfeited along with other action as the Corporation deems fit. The EMD of all unsuccessful bidders shall be returned only after placement of order with the successful bidder. "

instead of

" An amount of ₹ 10500/= ( **Rupees Ten Thousand Five Hundred** ) only to be submitted along with the offer.

The Vendor can make the payment of the EMD as explained above in (b) Step 3.

If a bidder withdraws the tender while it is under consideration or, after placement of order, the bid security /EMD shall be forfeited along with other action as the Corporation deems fit. The EMD of all unsuccessful bidders shall be returned only after placement of order with the successful bidder. "
