**Construction of a Temporary Water Collection Tank along with Laying of 40 mm diameter HD Polyethylene Pipe from the School Campus of Govt. Secondary School, Tato, to NEEPCO Colony, Tato**, as detailed at Part-4 (Technical Specifications) and Part-6 (Bill of Quantities) of Bid Document.
3. **Bidding Procedure:**  
The Bidder shall submit Bids under Single-Stage Single-Envelope bidding system through online. The Single Envelope shall contain all the documents such as Tender Forms & Data Sheets and Price Bid.
4. **Time of Completion:**  
The scheduled Time for Completion of Works shall be 60 (Sixty) days reckoned from the date of issue of Letter of Acceptance or handing over of site by the Employer, whichever is later.  
The bidders shall submit a construction programme considering Equipment planning, and mobilization of other resources so as to complete the Works within the stipulated Time for Completion.
