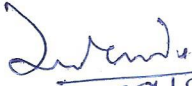

 - a) One completed work costing not less than the amount equals to 80% of the Tendered value **OR**
 - b) Two completed works each costing not less than the amount equal to 50% of the Tendered value **OR**
 - c) Three completed works each costing not less than the amount equal to 40% of the Tendered value.

- (iv) Certificate to be enclosed as a proof of SC/ST.
