Notice Inviting Tender

The undersigned on behalf of “North Eastern Electric Power Corporation Limited” (NEEPCO) hereby invites sealed tender with a validity of 180(one hundred eighty) days from registered contractor(s) for execution of the following works of Ranganadi Hydro Electric Plant(405MW),NEEPCO Ltd, Yayee, District- Papum pare, Arunachal Pradesh. Terms & conditions are detailed herein as under:

- 1. Name of the work:** ‘Improvement of Power House Colony road from Main Security Gate towards power house gate from ch 1530.00 to 1680.00 at hoj, RHEP (Group-VII), A.P’.
- 2. Scope of the work:** The work is to be executed as per technical specification attached in the tender document and as mentioned in the schedule of items enclosed in the tender document.
- 3. Rate per unit basis:**
 - 3.1 Rate for the scope of work of respective item against specification shall be “*FIRM till completion of work irrespective of any quantity variation*”. No escalation of the rates quoted will be admissible.
 - 3.2 Bidders are to quote unit rates in figures and words for the indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English, in Indian currency both in figures and words. In case of discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rates and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the correction made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initiated by the bidders.
 - 3.3 **Taxes, Duties & Levies:** Bidders shall quote their rates against respective item specification inclusive of all taxes and duties including Forest Royalty, Monopoly charges, Entry Tax, Work Contract Tax and Building Cess, Service tax etc. No extra charge on this account shall be paid by the corporation. Forest royalty clearance certificate is to be submitted by the contractor along with their bills for the forest products, if any utilized by them for the work.
- 4. Tendered Amount:**
 - 4.1 **₹ 8,31,965.00** (*Rupees Eight Lakhs Thirty One Thousand Nine Hundred and Sixty Five Only*) to show the probable cost of the work which is inclusive of requisite Building Cess, Work contract tax, service tax, transportation costs etc.
 - 4.2 Building cess, work contract tax and service tax as applicable will be deducted from the work value
- 5. Payment Terms:**
 - 5.1 Payment will be released after satisfactory completion of work as certified by the engineer-in-charge. No part payment/advance payment will be entertained.
 - 5.2 90% payment will be released on successful completion of the work. Balance 10% will be kept as security deposit (performance guarantee) which will be released after expiry of defect liability period for the work. In case of any defect in the work detected after the completion of the work within the defect liability period, shall be made good by the contractor at his own risk, cost and no extra payment shall be made by the corporation.
- 6. Paying authority:** The paying authority shall be Manager (F), F&A wing, RHEP, Yazali (A.P).
- 7. Time of completion:** The work shall be completed within **30(Thirty)** days from the date of issue of the work order.
- 8. Compensation for delay:** In case of delay in work of items within the stipulated period indicated in clause 4 above, compensation for delay at the rate of 0.5%(half percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of 10%(ten percent) of the contract price.

- 9. Defect liability period:** The work shall be subjected to a defect liability period of **12(Twelve)** months from the date of completion of work in all respect. The nature and extent of defects to be considered for the purpose of defect liability shall be decided by the engineer-in-charge and decision of the Engineer-in-charge in this matter shall be final and binding. In case of non-compliance of clause no-5.2, the security deposit shall be forfeited.
- 10. Security deposit:** 10% (ten percent) of the work value shall be retained as security deposit and the same shall be released after expiry of defect liability period or defect rectification work if any arises whichever is later.
- 11. Earnest money deposit:** 2.5% of the estimated amount for general and 1% for SC/ ST contractor.
NEEPCO registered contractors are exempted from submitting the EMD along with the tender.
- 12. Submission of documents:**
The following documents are to be submitted along with the bid document.
- (i) Certified copy of registration with RHEP, NEEPCO, Yazali (A.P) in case of RHEP registered contractor.
 - (ii) Copy of Income Tax PAN Card, Copy of VAT registration/TIN/Sales Tax registration number (for supply of goods) and Service Tax registration number (for services) as applicable.
 - (iii) However, those who have already submitted the above mentioned documents to this office need not to submit.
- 13. Terms & condition for submission of tender:**
- i) Non transferrable bid documents can be obtained from the office of the Sr.Manager (Civil), Hoz Civil Maintenance Wing (HCMW), RHEP, Arunachal Pradesh on submission of application addressed to the Sr.Manager (Civil), HCMW by paying a non-refundable bid fee of ₹100 (rupees one hundred only) in favour of “NEEPCO Ltd, Yazali” from **29.08.2016** to **26.09.2016** in any working days between 10:00hrs to 17:00hrs. Bid documents shall be issued only to registered contractor of RHEP subject to submission of documentary evidence thereof.
 - ii) Last date of submission of bid :On **27.09.2016** up to 13:00hours at the office of the Sr. Manager(C), Hoz Civil Maintenance Wing, RHEP,NEEPCO Ltd, Yayee (A.P)
 - iii) Date of opening of the bid: On **27.09.2016** at 15:30hours at the office of Sr.Manager(C), Hoz Civil Maintenance Wing, RHEP,NEEPCO Ltd, Yayee (A.P)
 - iv) Sealed tender is to be submitted to the office of the Sr.Manager(C), Hoz Civil Maintenance Wing, RHEP,NEEPCO Ltd, Yayee (A.P) in the specified tender box in person in the following address:

 - viii) Tender received by fax or e-mail or by post shall not be accepted.
 - ix) The corporation cannot be held responsible for non-receipt of tender.
 - x) The corporation reserves the right to accept or reject any or all tenders in part or full without assigning any reasons thereof and is not bound to accept the lowest bid.
