The North Eastern Electric Power Corporation (NEEPCO), a public Sector Enterprise under the Ministry of Power, Government of India invites Single -Stage Bid through **ON-LINE** bidding from reputed and experienced bidders for the following work.

QUALIFYING REQUIREMENTS:

- 1) Prospective bidders have to submit the following particulars along with their bid. Without the following documents, the bid shall not be considered to any intending firm(s)/ contractors and bid will be rejected and their bid will be considered as **disqualified bid**.
- 2) I) Experience of having **successfully completed similar nature of works under State Govt./ Central Govt./PSU works (work order copy to be enclosed with the tender document)** during last 7 (Seven) years ending last day of the month previous to the one in which applications are invited should be either of the following:
 - a) One completed work costing not less than the amount equals to 80% of the Tendered value OR
 - b) Two completed works each costing not less than the amount equal to 50% of the Tendered value OR
 - c) Three completed works each costing not less than the amount equal to 40% of the Tendered value.
 - I). Solvency Certificate from any Nationalized Bank.
 - II).Pan Number.
 - III).Certificate to be enclosed as a proof of SC/ST.
 - IV).VAT Registration
 - V).Service Tax Registration.
 - V). Labour license
 - VI). Trade License.
- 3) **Bidders shall have to submit self-attested documents as mentioned above in On-line.**
- 4) **SUBMISSION OF BID: The bid shall be submitted online only.**
- 5) **BID FEE: (OFF-LINE):** Bidders shall have to submit a BID FEE (non-refundable) for participation in this instant tender of **Rs.2,000.00** (Rupees Two thousand) only in the form of DD from any Nationalized or Scheduled Bank in favour of NEEPCO Ltd. Bokuloni Chariali, Dibrugarh, Assam **in a sealed envelope**

superscripted as "BID FEE for On-Line NIT No. AGBP/CWC/17 Dated.19.08.2016" on or before bid submission date & time as mentioned below.

- 6) **EARNEST MONEY DEPOSIT (EMD) OFF-LINE:** Bidder shall have to submit Earnest Money as mentioned above in a Sealed **Envelope** superscripted as "**Earnest Money for On-line NIT No. AGBP/CWC/17 Dated.19.08.2016**" on or before bid submission date & time as mentioned below. The EMD shall be in the form of Demand draft from a Nationalized Bank drawn in favour of NEEPCO Ltd, Bokuloni Chariali, Dibrugarh payable at State Bank of India, Bokuloni Chariali Branch, Dibrugarh. **Bid without BID FEE & EMD in the manner specified above shall be summarily rejected.**

Both the Bid Fee and EMD shall have to be submitted to "**The office of Sr. Manager (C), CWC, AGBP, NEEPCO Ltd. PO: Bokuloni Chariali, Dist: Dibrugarh, Assam, PIN: 786191**" in sealed envelope separately superscripted as "**On-Line NIT No. AGBP/CWC/17 Dated.19.08.2016**".

The EMD of unsuccessful bidders shall be returned after finalization of the bid. However, EMD of successful bidder shall be returned after submission of Security deposit (SD).

- 7) Failing to comply above or without submission of any one of the above mentioned documents or criteria, the bid shall not be considered for **any evaluation and summarily rejected.**

8) **SUBMISSION and OPENING of BIDS:**

In case the due date happens to be a holiday/bandh, the tender shall be opened at **16:00** hrs of next working day.

In case the office remains closed on any of the dates mentioned above due to any reason whatsoever, then the said dates shall automatically be considered postponed to the next working day. One representative of the intending bidders at their option may be present during the bid opening.

9. Participation in Bids:

i. Portal Registration for e-tendering:

The bidders intending to participate in the e-tendering and to download the detailed bid document have to register themselves in the NEEPCO's e-tendering portal <https://neepco.abcprocure.com>. The registration shall

be valid for one year from the date of registration. The Bidders who have already registered in NEEPCO's e-tendering portal having valid registration need not to register again. However, such bidders are to ensure that their registration in the e-tendering system is valid till the completion of the entire bidding process of the relevant NIT. Relevant information about the bidder required for registration is available in the portal.

ii. Bidder Registration Fee:

The fee for Bidder Registration in the portal is Rs.3, 000.00 (Rupees Three thousand) only per year (Non-refundable). **All vendor registration in on line either by net banking or NEFT/RTGS. Except these no other forms of registration is allowed.**

- iii. Procedure for Payment of Bid Documents FEE & Earnest Money:** Bidders to upload scan copies of DD against **Bid Fee and EMD as a proof along with documents in on line**. However, bidders to submit the original Demand Draft against Bid Fee and Earnest Money Deposit on or before bid submission date & time given under Clause No.8 above.

v. BIDDING PROCEDURE:

- (a) The bidder shall submit their bid under single Stage Bid System in the electronic form through **e – Tender in three separate sealed envelopes i.e (1) Envelope for Qualifying Documents and (2) upload scan copies of DD against Bid Fee and EMD (3) Envelope for Price Bid.**
- (b) Price Bid shall be opened only for those bidders who fulfill the qualifying requirements as mentioned at Clause No.1.0 and 2.0 above. Sealed EMD envelope shall be opened along with bid.
- vi.** NEEPCO may allow preferences to Govt. / PSU / SSI / NSIC units as per Govt. Policy and guidelines.
- vii.** Bidders are requested to visit <https://neepco.abcpur.com> regularly for any corrigendum/amendments/modification/clarification of the bid document.
- viii.** Submission of bids shall not automatically construe qualification of bid document.
- ix.** The bidders shall not be entitled during the validity period of their offer without the consent in writing of the Corporation to revoke or withdraw their tenders or vary the tender /term thereof in any respect, failing which the Corporation shall forfeit his Earnest Money deposited along with the tender.
