Umrongso , Dima Hasao ,Assam as per Scope of Work and Terms & Conditions stated below.

1. Qualifying requirement of the Bidder:

- 1.1 Bidder should state their Tax payer Identification Number, VAT Registration No. and PAN. Without which Bids may be summarily rejected.
- 1.2 Bid from authorised dealer should be supported with valid dealership certificate/ authorization letter issued by the manufacturer.
- 1.3 The intending bidder must have experience in execution of supply order to any Government department/ PSU (order.

Documentary evidence (supply order copies) in support of execution of supply must be submitted along with the bid. Non-submission of documents in support of similar experience may result in disqualification.

2. Price Basis:

The Price shall be quoted on FOR Umrongso basis indicating all charges towards freight & transit insurance and Taxes & Duties. All prices and rates shall be clearly indicated both in figures and words. Applicable rates of taxes & duties shall be clearly stated in the bid. The quoted prices shall remain FIRM during the currency of the contract.

3. Taxes & Duties:

Taxes and duties will be paid at actual prevailing at the time of dispatch against submission of documentary evidence.

4. Earnest Money:

EMD of Rs.5,000/ of the quoted value in the form of Demand Draft duly pledged in favour of NEEPCO Ltd., payable at SBI, KHEPA, Garampani Branch, P.O. Umrongso (SBI Code-4812) should be submitted along with the tender. Tender without EMD shall be rejected.

5. Tender fee:

6. Payment Terms :

100% of the contract price along with 100% taxes and duties shall be paid after receipt of materials at site in full & good condition.

7. Delivery Period:

The materials shall be delivered and commissioning at site within 60 (sixty) days from the date of awarding the contract / issue of order.

8. Liquidated damage:

LD @ 0.5% on the contract value for per week of delay in delivery and commissioning subject to a maximum of 10% on the contract value shall be applicable.

9. Guarantee / Warranty:

- 9.1 The materials supplied shall be warranted / guaranteed as per manufacturer's norms, if applicable.
- 9.2 The successful bidder shall supply the materials to the satisfaction of the Engineer-in charge. Defective materials shall be replaced/ rectified by the supplier at free of cost immediately on intimation from this end.

10. Submission of Bid:
