    - One completed works costing not less than the amount equal to 70% of the estimated cost.
  - Valid work permit/ Firm registration.
  - Solvency certificate from any Nationalised bank.
  - PAN number.
  - VAT registration certificate.
  - PF registration, if any.
  - Application for issue of tender document without which application may not be considered for issue of tender document.
- Proof of document/documents must be submitted for **EMD concession@ 1%** with the Bid Document if applicable, otherwise Bidder will be chosen as General category.
