North Eastern Electric Power Corporation Ltd (NEEPCO) NEEPCO invites Sealed Single-Stage Two Envelope Bids through International Competitive Bidding route with 180 days validity from eligible bidders for supply of the mechanical parts required for MI , CI & BI of Units at Agartala Gas Turbine Plant (Make of Unit: GE make frame V gas turbine supplied by EGT, Model No. G5371(PA)) located in Tripura, India.

1.0 Qualifying Requirement for Bidders:

- 1.1 Technical Qualifying Requirements.
- a) The bidder must be Original Equipment Manufacturer (OEM)/ Authorized Vendor or Sub-Vendors of OEM/Reputed manufacturers of Spares for GE make Frame V Gas Turbine.
- b) Bidder must either himself possess or have access to the necessary technology for manufacturing of spares of GE make Frame V gas Turbine applicable for model no. G5371PA for AGTP supplied by M/S EGT.
- c) If the tenderer is not the OEM, the tenderer shall have to submit certificate confirming that his offered parts are new, unused, in good condition and shall form fit and function properly without any modification in the GE make Frame V Gas Turbine at AGTP.
- d) The tenderer shall have to submit guarantee/warranty certificate for genuineness of the items and its satisfactory performance during warranty period.
- e) The tenderer shall have to submit the Proof of supply of similar parts to any PSU/Govt. Companies.

1.2 FINANCIAL QUALIFYING REQUIREMENTS:

(a) Minimum Average Annual Turn Over (MAAT):

The average annual turnover of the bidder in the best 3 (three) financial years out of the last 5 (five) years financial year should not be less than INR 11.75 million or

equivalent USD/EURO. Other income will not be considered for arriving at annual turnover.

(b) Net Worth:

The Net Worth of the bidder as on last day of the preceding financial year shall not be less than 50% of the Paid up Share Capital.

The Net Worth shall be calculated based on Subscribed and Paid-up Capital + Free Reserves + Unallocated balance surplus amount of Profit & Loss Account if not reduced from Reserves.

Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account & detailed Schedule and other financial statements for the preceding 5(five) financial years, ending 31st March of the previous Financial Year, along with Letter of adequacy and commitment from their Bankers/Financial Institutions of International repute should be furnished along with their bids for evaluating the above financial criteria. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable.

(c) Liquid Assets:

The bidder should have liquid assets or / and evidence to availability of unutilized credit facilities of not less than INR 2.94 million or equivalent USD/EURO.

The certificate of the Banker regarding the availability of unutilized credit facility should not be dated earlier than 30 (thirty) days prior to the date of opening the bid.

(d) Bid Capacity:

The available Bid Capacity of the Bidder at the time of submission of Bid, calculated as under should not be less than the estimated cost of the work put to tender:

Bid Capacity = $A \times N \times 2 - B$, where,

A = maximum value of works executed in any one year during last 7 (seven) years (at current price level).

N = Completion time of the proposed work in years.

B = Value at current price level of existing commitments and on going works to be completed during next N years.

Bid capacity shall be assessed at the time of submission of Techno-commercial Bid, for which the bidder shall have to submit documentary evidence in support of "A" & "B" above along with their Bid.

- 1.3 Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 1.1 and 1.2 above shall be submitted along with Techno-Commercial bids. For qualifying requirements specified at Para 1.1 above, the documents should be in the form of Certificate of Clients / Owners. Bids submitted without fulfilling the qualifying requirements shall be rejected.
- 1.3.1 A declaration with supporting documents that the bidders satisfy the requisite qualifying criteria as stipulated at Clause 1.1 and 1.2 above.
- 1.4 The bidders shall also submit valid Sales Tax Clearance Certificate, Copy of Service Tax Registration.
- 1.5 The bidders shall also provide satisfactory evidence with respect to the following:
 - a. They do not anticipate change in the Ownership of their concern during the proposed period of work. If such a change is anticipated, the scope and effect thereof shall be defined.
 - b. They have adequate financial stability and status to meet the financial obligations pursuant to the scope of the works. They shall submit at least 3 (three) copies of their audited Annual Reports and balance sheet for the last 3 (three) years and the latest Sales Tax Clearance Certificate and latest Banker's certificate indicating amount in support of solvency.
 - c. In case bidders are unable to furnish such certificates, they shall give valid reason for the same. The Purchaser reserves the right to reject any bid if Sales Tax Clearance Certificate or the reasons for the bidders' inability to furnish such a certificate are not mentioned in the bids.
- 1.6 In addition, bidders shall satisfactorily establish that they fully meet the qualifying requirements. This is essential for consideration of Bidders' proposal.
- 1.7 Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by any bank.

2.1 Portal Registration:

The fees for Vendor Registration in the portal is Rs.3000.00 (Rupees three thousand) only per year (Non refundable).
