GENERAL TERMS & CONDITIONS

1.0 SCOPE: Supply, Transportation, Transit Insurance, Delivery including Loading -Unloading of chemical up to AGTP site (FOR basis).

2.0 TRANSPORTATION:

The Acid shall be supplied by HDPE drums of Size 100-125 Ltr capacities on door delivery basis. Materials should be transported in a manner which meets all safety requirements.

3.0 DELIVERY PERIOD / COMPLETION TIME:

- 3.1 Delivery of the item as specified shall be made at AGTP, NEEPCO Ltd, R.C Nagar District: west Tripura, within 45(fortyfive) days from the date of dispatch Clearance issued by AGTCCPP NEEPCO Ltd.
- 3.2 Quantity of the materials specified above is tentative requirement for 10-12 month from the date of this order and liable to be increased or decreased based on the actual consumption. As the material falls under consumable category; the same shall be dispatched as per our actual requirement pattern, which shall be intimated from time to time and restricted to one full truck load at a time.

The materials shall be delivered in parts depending on the requirement of AGTP, NEEPCO from time to time. No materials shall be dispatched until clear instruction regarding dispatch is given to the supplier.

4.0 LIQUIDATED DAMAGE FOR DELAY IN COMPLETION:

If the performance of the Contract is delayed beyond the dates stipulated in the Contract due to reasons attributable to the Contractor, the Contractor will be liable for payments as liquidated damages for the delay at the rate $\frac{1}{2}$ (half) percent of the Contract Price per week or part thereof subject to a maximum of 10% (ten percent) of the Contract Price. However, even after imposition of this clause by the Purchaser, the supplier does not take necessary steps to complete the supply, the Purchaser will then cancel the incomplete portion of the supply and can get the same done through any other agency at the risk and cost of the Contractor. The decision of the Purchaser in this respect shall be final and binding on the Contractor.

5.0 TERMS OF PAYMENT:

- i) 90% Payment shall be released within 30(thirty) days after receipt and acceptance of materials at AGTCCPP site for which the supplier shall submit the following documents to the consignee.
 - a) Copy of Invoices in Triplicate.
 - b) Packing List/Challan.
 - c) Test Certificate.

And balance 10% after completion of warranty period.

- (ii) Paying Authority shall be the Manager (F), NEEPCO, AGTCCPP
- (iii) Consignee: Dy.Manager (E), store, NEEPCO, AGT CCPP, R.C Nagar. Tripura(W), Pin 799008.

6.0 INSURANCE:

The Contractor shall at his own cost, arrange, secure and maintain Insurance as may be pertinent to the works and obligatory in terms of law to protect his interests and the interest of the Purchaser against all possible risks, without in any manner limiting its obligations and responsibilities, in the joint names of the Purchaser and the Contractor, so as to cover any damage or loss of materials during handling, transporting to site, and subsequent taken over by the Purchaser, against all risks which are insurable for their replacement value, for which the Contractor shall be responsible according to the Contract.

The said insurance shall be valid upto the date of receipt of materials at site.

7.0 QUALITY ASSURANCE

Supplier should ensure that quality of the materials should be as per our specification and their relevant IS as mentioned.

8.0 TESTS:

- 8.1 The chemical shall be subjected to all types of tests at the manufacturer works in accordance with requirements as per relevant Indian Standards prior to dispatch of all the item. All authentic test reports/certificates shall be submitted in respect of the tests conducted.
 - Neither the waival of inspection / testing or acceptance after inspection and or testing by the Corporation shall relieve the supplier in way of the responsibility of supplying the material strictly in accordance with the specifications,. In any case, the supplier shall remain fully responsible for satisfactory performance of the materials.
- 8.2 On receipt of materials at site Weight and concentration analysis will be carried out in AGTCCPPs DM plant laboratory by collecting samples.
- 8.3 Rejection of Materials: If the materials are found to be defective, at the time of receipt /during utilisation, the same shall be rejected and the supplier will have to replace the same at their own cost up to the destination.
- 8.4 Shelf Life Certificate: Shelf life Certificate for 12 months from the date of supply of Chemicals shall be submitted.

9.0 FORCE MAJEURE:

If either Manufacturer or Purchaser (hereafter called as party) is temporarily unable by reason of Force Majeure or the laws or regulations of India to meet any of its obligations under this Contract and if such party gives to the other party written notice of the event within 14 (fourteen) days after its occurrence, such obligations of the party as it is unable to perform by reason of the event shall be suspended for as long as the Force Majeure condition continues.

The Purchaser or his authorized representative, on receipt of notification, shall ascertain the facts and extent of the delays and suitably extend the time for completing the work or stage of work where, in his judgment the findings of facts justify an extension. The period of extension of time shall be determined by the Purchaser or his authorized representative after taking into consideration the nature of the work delayed and practicability of its execution during the period of extension.

The term "Force Majeure" shall, herein, mean riots (other than among the Contractor's employees), Civil commotion (to the extent not insurable), war (whether declared or not), invasion, act of foreign enemies, hostilities, civil war, rebellion, revolution, insurrection, military or usurped power, damage from aircraft, nuclear fission, acts of God, such as floods, earthquake, lightning, fires not caused by Contractor's negligence and other such cause over which the Contractor has no control and are accepted as such, by the Purchaser, whose decision shall be final and binding. In the event of either party being rendered unable by "Force Majeure" to perform any obligation required to be performed by them under the

Contract, the relative obligation of the party effected by such "Force Majeure" shall be treated as suspended for the period during which such "Force Majeure" cause lasts, provided the party alleging that it has been rendered unable, as aforesaid, thereby shall notify within 14(Fourteen) days of the alleged beginning and ending thereof giving full particulars and satisfactory evidence in support of such cause.



10.0 GUARANTEE / WARRANTY:

For a period of 12(twelve) calendar months from the date of receipt of materials (called the Warranty Period), the Contractor shall remain liable to replace any defective materials at his own expense.

11.0 ARBITRATION:

Except where otherwise provided, if at time, any question of a dispute or difference of opinion whatever shall arise between the Contractor and the Corporation upon or in relation there to or in connection with this Contract, either of the parties may give to the other notice in writing, of the existence of such questions, disputes or differences and if the matter is not settled amicably by and between the parties and on rejection, such matter of dispute or difference of opinion shall be referred to the Arbitration strictly in accordance with the provision contained in the Arbitration and Conciliation Act 1996 (Act. No. 26 of 1996), and any amendment thereto and any rules made there under and to such other order or orders, instruction issu ed by the Government of India time to time in this connection. The venue of Arbitration for shall be Agartala, India.
