**Item no. 2 :** Providing and fixing 1st quality ceramic glazed wall tiles TILE - WHITE ( 8 inch X 12 inch 9001 in skirting, risers of steps and dados over 12mm thick bed of cement mortar 1 : 3 ( 1 cement : 3 fine sand ) jointed with ordinary cement slurry including pointing with white cement mixed with pigment of matching shade complete.

And

**Item no. 3 :** Providing and laying 1st quality ceramic glazed floor tiles [ANTI IVORY size 12 inch x 12 inch (-anti skid) conforming to IS 15622 over a bed of 20mm thick cement mortar 1 : 4 ( 1 cement : 4 sand ) jointed using ordinary cement slurry including pointing with white cement mixed with pigment of matching shade complete.

**Instead of**

**Item no. 3** Providing and laying 1st quality ceramic glazed floor tiles [ANTI IVORY size 12 inch x 12 inch over a bed of 20mm thick cement mortar 1 : 4 ( 1 cement : 4 sand ) jointed using ordinary cement slurry including pointing with white cement mixed with pigment of matching shade complete.
