

Sealed single part quotation with 90 (ninety) days validity are invited from reputed Manufacturer / Authorized Dealer for supply, installation and commissioning of the Radio Equipments for Point-to Point Data Link in between Doyang Dam & Power House and re-align the existing Radio Equipments for Point-to-Point Data Link in between Administrative Building & Dam at Doyang H.E. Plant, NEEPCO Ltd., Doyang, Dist.- Wokha, Nagaland, Pin-797100

Terms & Conditions:

1. **SCOPE:** Supply, Transportation, Transit Insurance, Delivery including packing, loading, unloading and successful installation, commissioning of Radio Equipments for Point-to Point Data Link at Doyang H.E. Plant, NEEPCO Ltd., Doyang, Dist.- Wokha, Nagaland, Pin-797100 as per specification mentioned at **ANNEXURE-I**. The scope also includes the re-align the existing Radio Equipments for Point-to Point Data Link in between Administrative Building and Dam required for establishing complete Data Link in between Administrative Building and Power House as a whole.
2. **ELIGIBILITY:** The Bidder must be an OEM or Authorized dealer who has executed and commissioned similar project. The authorized dealer has to submit valid DEALERSHIP CERTIFICATE along with their offer. Documentary evidence of Experience and past performance has to be submitted along with the Bid documents.
Bidders should state their Tax Payers Identification Number, VAT Registration Number and Permanent Account Number without which bids may be summarily rejected.
The bidders have to quote rate for all items along with taxes and duties, else the bid shall be liable for rejection.
3. **PRICE BASIS:** Rate should be quoted on F.O.R.-Doyang basis including handling, packing and loading charges exclusive of Taxes & Duties. All prices should be clearly indicated both in figures and in words.
4. **TAXES & DUTIES:** The Rate of taxes & duties may be mentioned separately and clearly.
5. **EARNEST MONEY DEPOSIT (EMD):** The bidder have to deposit earnest money @ 2.5% of the quoted value in the form of Demand Draft from any Nationalized Bank in favour of **NEEPCO Ltd., payable at SBI, Doyang Branch (Br. Code- 9351), Doyang, Nagaland** along with their offer, failing which the tender will not be considered.
 - a. EMD of all unsuccessful bidders will be returned only after finalization of the bid.
 - b. If the bidder withdraws the bid while it is under consideration, his EMD shall be forfeited and will take other action as per norms of the Corporation.
 - c. In case the bidder is exempted from submission of EMD etc., documentary evidence in support of the same should be submitted along with the Bid.
 - d. EMD of successful bidder shall be retained as security deposit towards satisfactory execution and completion of the work and will be released along with the payment of the work.
6. **DELIVERY, INSTALLATION AND COMMISSIONING:** The entire scope of the work shall have to be completed within 30 (thirty) days from the date of issue of LOI/detail order to the selected bidder.
7. **GUARANTY/ WARRANTY:** The materials supplied shall be guaranteed / warranted against any manufacturing defect as per manufacturer's norms. The guaranty / warranty period for the Materials may clearly mention in the offer.

8. **PAYMENT TERMS:** Ninety Percent (90%) of the material value along with hundred percent (100%) taxes & duties shall be released on receipt of the materials in full and good condition and successful installation & commissioning of the equipments. Remaining ten percent, (10%) shall be released after expiry of the warranty period subject to the satisfactory performance of the equipments. Bank details for RTGS payment are to be provided for prompt payment and all bank charges, if any, shall be contractors account.
9. **LIQUIDATED DAMAGE:** Delay in completion of the work in all respects (i.e. supply, installation and commissioning) shall attract liquidated damage applicable @ 0.5% (half percent) of the order value per week subject to a ceiling of 10% (ten percent) of the order value.
10. **REJECTION OF DEFECTIVE MATERIALS:** Material found defective at the time of received must be replaced at the cost of the supplier.
11. **SUBMISSION OF BID:** Sealed Tender superscripted with “**Quotation for Supply, Installation and Commissioning of Radio Equipments for Data Link against NIQ No. 03/2016/IT/DHEP**” on the envelope should be submitted by hand with written authorization or registered post to “**The Sr. Manager (IT), NEEPCO Transit Camp, HPB Girl’s College Road, Chandan Nagar, Golaghat, Assam, Pin- 785621**”. The Corporation shall not be responsible for any postal delay.
Last Date and Time of Submission of Tender: The bid shall be received till 15:00 hrs of 24/03/2016 in the above mentioned address.
Date and Time of Opening of Tender: The bid shall be opened at Doyang H.E. Plant, Doyang on 25/03/2016 at 11:30 hrs. In case 25/03/2016 is a holyday, the bid shall be opened on next working day at 11.00 hrs.
12. The final quantity may increase or decrease.
13. All the above terms and conditions are non-deviable. Tenders not complying with all above may be summarily rejected.
14. The Corporation reserves the right to change/modify the requirements or to postpone/reject the tender without conveying any reason thereof and is not bound to accept the lowest bid.
