- 1) Prospective bidders have to submit the following particulars along with their bid. Without the following documents, the bid shall not be considered to any intending firm(s)/ contractors and bid will be rejected and their bid will be considered as **disqualified bid**.
- 2) I) Experience of having successfully completed similar nature of works under State Govt./ Central Govt./PSU works (work order copy to be enclosed with the tender document) during last 7 years ending last day of the month previous to the one in which applications are invited should be either of the following:
 - a) One completed work costing not less than the amount equals to 80% of the tendered value OR
 - b) Two completed works each costing not less than the amount equal to 50% of the tendered value OR
 - c) Three completed works each costing not less than the amount equal to 40% of the tendered value.
- II). Solvency Certificate from any Nationalized Bank.
- II).Pan Number.
- III).Certificate to be enclosed as a proof of SC/ST
- IV).VAT Registration ..
- V). Service Tax Registration.
- VI).Trade License.
- 3) Bidders shall have to submit self-attested documents as mentioned above.

- 6) **EMD: EMD (OFF-LINE):** Bidder shall have to submit EMD as mentioned above in a separate **SEALED ENVELOPE** superscripted as "EMD for e-tender No. AGBP/CWC/11 Dtd. 07/06/2016." on or before submission date as mentioned in the bid document. The EMD shall be in the form of Demand draft from a Nationalized Bank drawn in favour of NEEPCO Ltd, Bokuloni Chariali, Dibrugarh payable at Bokuloni Chariali, Dibrugarh. **Bid without EMD in the manner specified above shall be summarily rejected.**

Both the Bid Fee and EMD envelopes shall be enclosed in a separate envelope and to be submitted to "The office of Sr. Manager (C), CWC, AGBP, NEEPCO Ltd. PO: Bokuloni, Dist: Dibrugarh, Assam, PIN: 786191" in a sealed envelope superscripted as "e-tender No. AGBP/CWC/11 Dtd. 07/06/2016." along-with other relevant documents as mentioned in the bid.

The EMD of unsuccessful bidders shall be returned after finalization of the tender. However, EMD of successful bidder shall be returned back after submission of SD (Security deposit).

- 7) Bidders shall submit their bids in the electronic form in <https://neepco.abcpocure.com>. Online bidding forms will be available in the above website.
- 8) Failing to comply above or without submission of any one of the above mentioned documents or criteria, the bid shall not be considered for **any evaluation and summarily rejected.**

9) **IMPORTANT DATES:**

- a. **STARTING DATE FOR DOWN-LOADING BID ONLINE:** 25/06/2016 (11:00 Hrs.)
- b. **PRE- ACCESSMENT OF SITE BY BIDDERS:** Interested bidders can access the site at AGBP, NEEPCO Ltd, P.O: Bokuloni, Dibrugarh prior to submission of BID documents during any working days (10:00 Hrs to 17:00 Hrs).
- c. **PRE-BID MEETING:** Bidders may clarify any points on 30/06/2016 (10:00 Hrs to 13.00Hrs).
- d. **END DATE FOR DOWNLOADING BID DOCUMENTS:** 07/07/2016 (12.00 HRS.)

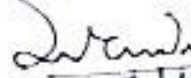
10). **INFORMATION TO BIDDERS :**

- i) **Portal Registration:** The bidders intending to participate in the e-tendering and download the detail bid document have to register themselves in the portal <https://neepco.abcpocure.com>. Relevant information about the bidder required for registration is available in the portal.
- ii) **Vendor Registration Fee:** The fee for Vender Registration in the portal is Rs.3, 000.00 (Rupees Three thousand) only per year (Non-refundable).
- iii) **Procedure for Payment of Bid Documents FEE & EMD:** Bidders to upload scan copies of DD against Bid Fee and EMD in the portal as a proof at e-mail ID: civil.agbp@gmail.com in due date & time as mentioned above. However, bidders to submit the original DD against Bid Fee and EMD along with the hard copy of documents to be submitted in due date & time as mentioned above.
